Example 1: If serving a warrant in Providence and you serve them on the third attempt then it would be $\$ 50.00+(\$ 7.50 \times 3)$ for a total of $\$ 72.50$.
Example 2: If serving a Subpoena to Logan and you serve it on your first attempt then it would be $\$ 20.00+\$ 2.50$ for a total of $\$ 22.50$.
