# 1. CALL TO ORDER

Chairman John Kerr called the meeting to order at 8:30 a.m.

# 2. ACTION ITEMS

### a. APPROVAL OF MINUTES - JANUARY 5, 2023

ACTION: Motion was made by Karl Ward and seconded by Mayor Holly Daines to approve the minutes of January 5, 2023 as written. The vote in favor was unanimous, 5-0 (David Zook and Brett Hugie absent for vote)

## 2. DISCUSSION ITEMS

#### a. AIRPORT MANAGER'S REPORT - JASON RIRIE

Jason Ririe gave the Manager's Report. It is included with these minutes as Attachment A.

John Kerr asked newly appointed board member, Ryan Snow, to introduce himself. Snow said he is currently the Providence City Manager. Prior to that job, he was Roosevelt City Manager and oversaw the airport as part of his duties. He was a financial manager for a heavy construction company before Roosevelt City Manager and signed the bidding documents of an airport project for the contractor, then signed the project completion documents for that same project as the owner representative after he became the city manager. He is also a pilot and has an aircraft at the Logan-Cache Airport.

#### b. WWII Tower Presentation – AARON Dyches and Stewart Hunsaker

John Kerr introduced this item saying that weather events necessitated USU to make the decision to divest ownership in the WWII Tower. There has been a lot of interest expressed by patrons of the airport to preserve the tower as a significant historic symbol.

Kerr read a letters from Bill Francis and Jim Peterson in favor of preserving the tower.

Ryan Snow asked who the owner of the tower is. Kerr responded that USU owns the tower currently, but is ready to transfer that ownership to someone else.

Karl Ward expressed a desire to search for grants, donations, etc. to work toward preservation. He and Jeannie Simmonds suggested that a historic committee should be created to explore options for preservation.

Aaron Dyches, speaking for Utah State, said they are willing to donate it to the Airport Authority or another entity who wish to work towards preservation.

After more discussion, Ryan Snow suggested a tour of the tower to help determine a future course of action. Kerr asked Snow to arrange a time for members of the Authority Board to tour the tower.

Kerr said the FAA does not offer any funding for historic preservation, but there are other organizations that do. He doesn't feel comfortable using airport funds that are not used for direct airport operations.
