- Cache County shall keep an ongoing dialogue with social services nonprofits to understand community needs and available services, even if there is no forthcoming funding.
- No remuneration or privileges of any kind shall be expected or given to any county officer, employee, or county elected official due to donations given to non-profit or volunteer organizations.

Ordinance No. 2022-33 Cache County, Utah

Sand Castle Ranch Rezone

An ordinance amending the County Zoning Map by rezoning 5.0 acres from the Agricultural (A10) Zone to the Rural 2 (RU2) Zone

Whereas, the "County Land Use Development and Management Act," Utah Code Ann. §17-27a-101 et seq., as amended (the "Act"), provides that each county may enact a land use ordinance and a zoning map establishing regulations for land use and development; and

Whereas, pursuant to the Act, the County's Planning Commission (the "Planning Commission") shall prepare and recommend to the county's legislative body, following a public hearing, a proposed land use ordinance and a zoning map, or amendments thereto, that represent the Planning Commission's recommendations for zoning the area within the county; and

Whereas, the Planning Commission caused notice of a public hearing for the rezone to be posted at least ten (10) days before the date of the public hearing; and

Whereas, on November 3, 2022, the Planning Commission held a public hearing, accepted all comments, and accepted all comments, and recommended the approval of the proposed amendments to the County Council for final action; and

Whereas, the Act also provides certain procedures for the county legislative body to adopt or reject amendments to the land use ordinance and zoning map for the county; and

Whereas, following proper notice, the County Council held a public hearing on December 6, 2022, to consider any comments regarding the proposed rezone. The County Council accepted all comments; and

Whereas, the Cache County Council has determined that it is both necessary and appropriate for the County to amend and implement this ordinance.

Now, therefore, the County Legislative Body of Cache County ordains as follows:

1. Statutory Authority

The statutory authority for enacting this ordinance is Utah Code Annotated Sections 17-27a Part 1 and Part 3, and 17-53 part 2(1953, as amended to date).

2. Adoption of amended Zoning Map

The County Council hereby amends the County's Zoning Map to reflect the rezone of the property affected by this ordinance and hereby adopts the amended Zoning Map with the amendment identified as Exhibit B, of which a detailed digital or paper copy is available in the Development Services Department.

3. Conclusions

- A. The location of the subject property is compatible with the purpose of the Rural 2 (RU2) Zone as identified under §17.08.030[A] of the Cache County Code as it:
 - i. To allow for residential development in a moderately dense pattern that can allow for rural subdivisions, and to allow for clustering plans larger than a single parcel. This type of development should be located and designed to not unreasonably impede adjacent agricultural uses, nor to unreasonably conflict with the development standards of adjacent municipalities.
 - **ii.** Does not unreasonably impede adjacent agricultural uses, nor unreasonably conflict with the development standards of adjacent communities.
 - **iii.** The property is appropriately served by a suitable public road, 3200 West, has access to necessary water and utilities, and adequate provision of public services.
- **B.** The location of the subject property is not located adjacent to a municipal boundary, but is located within close proximity to other properties in the RU2 Zone and is consistent with the character and development pattern in the surrounding area.

4. Prior ordinances, resolutions, policies, and actions superseded

This ordinance amends and supersedes the Zoning Map of Cache County, and all prior ordinances, resolutions, policies, and actions of the Cache County Council to the extent that the provisions of such prior ordinances, resolutions, policies, or actions are in conflict with this ordinance. In all other respects, such prior ordinances, resolutions, policies, and actions shall remain in full force and effect.

6. Effective date

This ordinance takes effect on <u>December 20</u>, 2022. Findings of Fact


A. Request description

- 1. A request to rezone 5.0 acres from the Agricultural (A10) Zone to the Rural 2 (RU2) Zone.
- 2. This rezone may allow the parcel to be legally divided into a maximum potential of 2 separate lots as part of a subdivision process. The current A10 Zone allows for a maximum of 1 buildable lot.
- 3. Staff has identified general information as pertains to the subject property to assist the Planning Commission and County Council in arriving at a decision. This information is reflected in the attached map (Attachment A) and in the following text:

a. Land Use Context:

- i. Parcel status: The subject properties are legal as it is in the same size and configuration as it was on August 6, 2008.
- ii. Average Lot Size: (See Attachment A)

The proposed RU2 zone allows a maximum density of 1 lot for every 2 acres, whereas the current A10 zone allows a maximum density of 1 lot for every 10 acres. With approximately 5.0 acres of property, the subject property cannot be further divided under the current A10 Zone standards. A rezone to RU2 may allow up to a maximum potential of 2 buildable lots, including one lot with the existing single-family dwelling.

- iii. Schedule of Zoning Uses: Under the current County Land Use Ordinance, the RU2 Zone is more restrictive in the uses allowed when compared to the Agricultural (A10) Zone. There are no uses that are allowed as a permitted or conditional use within the RU2 Zone that are not allowed as a permitted or conditional use within the A10 Zone. The following uses are conditional uses in the A10 Zone but are not allowed in the RU2 Zone:
 - Agricultural Manufacturing
 - Recreational Facility
 - Cemetery
 - Private Airport
 - Concentrated Animal Feed Operation
 - Livestock Auction Facility
 - Topsoil Extraction
- iv. Adjacent uses: The properties adjacent to the subject rezone are primarily used for agriculture with a few single family dwellings. The closest Logan City boundary is located approximately 1.4 miles east of the subject property along 600 South; and the closest Mendon City boundary is located approximately 3.15 miles to the west of the subject property along 600 South.
- v. Annexation Areas: The subject property is located within the Logan City future annexation area. Logan City was notified of the proposed rezone as part of the noticing requirements, but have not provided written comments to staff as of the preparation of this staff report.
- vi. Zone Placement: As identified by the Planning Commission and the County Council at the time the RU2 Zone was adopted, the intended/anticipated placement of this zone was in areas of the unincorporated county adjacent to municipalities.
 - The nearest RU2 zone is immediately to the subject property on the south side at the corner of 600 South and 3200 West. This RU2 Zone was approved as the Whittier Rezone on 5.0 acres in 2016 per Ordinance 2016-01. The Whitter Subdivision was subsequently approved as a 2-lot subdivision in 2016.

The next closest RU2 Rezone, approximately 1.85 miles away from the subject property as the crow flies, was approved in 2013, per Ordinance 2013-10, as the Daugs Minor Subdivision Rezone. The original Daugs Minor Subdivision was approved in 2000 as a 3-lot subdivision on 12.8 acres in the Agricultural Zone under a different subdivision code that allowed for a higher density. After the 2013 rezone was approved, a subdivision amendment was recorded in 2014 creating a 4th lot within the subdivision; no additional lots have been created since then.

The next closest RU2 Rezones are located along the eastern (i.e., Mountain View Rezone (2021-08)) and south-eastern municipal boundaries of Mendon City (i.e., Mountain View Meadow Rezone (2018-13), Christy Rezone (2021-17) & Christy Farm Rezone (2022-15). The Mountain View Rezone was approved on 6.7 acres allowing a maximum of 3 building lots; a 3-lot subdivision has been approved but has not yet been recorded. The Mountain View Meadows Rezone was approved on 6.3

acres and a 3-lot subdivision was recorded in 2019. Christy Rezone was approved on 5.0 acres immediately west of the Mountain View Meadows Rezone as Ordinance 2021-17 allowing a maximum of 2 building lots instead of one under the A10 Zone; a subdivision application has not been submitted to date. The other RU2 Rezone on the south side of 2000 South across from the Christy Rezone was approved earlier this year as Ordinance 2022-15 on 7.41 acres allowing a maximum of 3 lots instead of one.

B. Ordinance—§12.02.010, §17.02.060; §17.08.030 [C]

- **4.** As per §17.02.060, Establishment of Land Use Authority, the County Council is authorized to act as the Land Use Authority for this application.
- **5.** The current County Land Use Ordinance does not specify appropriate locations for the Rural 2 (RU2) Zone but does contain possible guidelines for its implementation. County Land Use Ordinance §17.08.030 [B] [1] identifies the purpose of the RU2 Zone and includes the following:
 - **a.** "To allow for residential development in a moderately dense pattern that can allow for rural subdivisions, and to allow for clustering plans larger than a single parcel. This type of development should be located and designed to not unreasonably impede adjacent agricultural uses, nor to unreasonably conflict with the development standards of adjacent municipalities.
 - **b.** To implement the policies of the Cache Countywide Comprehensive Plan, including those regarding improved roadways, density based residential standards, clustering, moderate income housing and municipal standards.
 - **c.** This zone must be appropriately served by suitable public roads, have access to the necessary water and utilities, and have adequate provision of public services."
- **6.** Consideration of impacts related to uses allowed within the RU2 Zone will be addressed as part of each respective approval process required prior to site development activities.

C. Access—16.04.040 [A], 16.04.080 [E], Road Manual

- 7. §16.02.010 Standards and Lot Size All subdivisions must meet the minimum lot and development standards as outlined in each base zone of the Cache County Zoning Ordinance and within this title.
- **8.** Table 17.10.040 Site Development Standards Minimum lot frontage required in the RU2 Zone is 90 feet.
- 9. §17.07.040 General Definitions Lot/Parcel Frontage: that portion of a development site that abuts a public or private roadway. For the purposes of determining setback requirements on corner lots, all sides of a lot adjacent to a roadway shall be considered frontage
- **10.** §16.04.040 [A] Roads All roads must be designed and constructed in accordance with Title 12 of the County Code.
- 11. §12.02.010 Roadway Standards Requirements for roadway improvement are provided in the current Manual of Roadway Design and Construction Standards (Road Manual).
- **12.** A basic review of the access to the subject property identifies the following:
 - **a.** Primary access to the subject property is from 3200 West, a County road.
- **13.** 3200 West:
 - **a.** Is an existing county facility that provides to a few residential dwellings, agricultural lands, and a farm.
 - **b.** Is classified as a Minor Local Road.
 - c. Is paved (i.e., double chip) and is approximately 17-18 feet wide.
 - **d.** Road is currently a dead end that meanders through a farm operation.

- e. Is maintained year round by the County.
- **f.** Future development will require road improvements along the frontage of the property at a minimum to meet the Minor Local Road Standards. The property to the west is in an Agricultural Protection Area, which may affect the ability to improve or expand the road.
- **g.** A draft Transportation Master Plan is considering 3200 West as a collector type road direct access to State Route 30.
- **h.** Is considered substandard as to standards of a Minor Local Road standard as to right-of-way, travel lane width, paved and gravel shoulder widths, and clear zones. The paved surface material is considered "OK" and the structural condition is "Fair", per the County Engineer's review.

D. Service Provisions:

- **14.** §16.04.080 [C] Fire Control The County Fire District had no comments on the rezone. Future access must be reevaluated and may require improvements based on the location of any proposed structure on lots created through a subdivision process.
- **15.** §16.04.080 [F] Solid Waste Disposal Logan City Environmental provides refuse collection in this area and states refuse containers must be placed on 3200 West for collection. The specific collection location and further requirements will be reevaluated based on any future development.

E. Public Notice and Comment—§17.02.040 Notice of Meetings

- **16.** Public notice was posted online to the Utah Public Notice Website on 21 October 2022.
- 17. Notices were posted in three public places on 21 October 2022.
- **18.** Notices were mailed to all property owners within 300 feet and Logan City on 21 October 2022.
- 19. At this time, no written public comments regarding this proposal have been received by the Development Services Office.

Planning Commission Conclusion

Based on the findings of fact noted herein, the Sand Castle Ranch Rezone is hereby recommended for approval to the County Council as follows:

- 1. The location of the subject property is compatible with the purpose of the Rural 2 (RU2) Zone as identified under §17.08.030[A] of the Cache County Code as it:
 - **a.** To allow for residential development in a moderately dense pattern that can allow for rural subdivisions, and to allow for clustering plans larger than a single parcel. This type of development should be located and designed to not unreasonably impede adjacent agricultural uses, nor to unreasonably conflict with the development standards of adjacent municipalities.
 - **b.** Does not unreasonably impede adjacent agricultural uses, nor unreasonably conflict with the development standards of adjacent communities.
 - **c.** The property is appropriately served by a suitable public road, 3200 West, has access to necessary water and utilities, and adequate provision of public services.
- 2. The location of the subject property is not located adjacent to a municipal boundary, but is located within close proximity to other properties in the RU2 Zone and is consistent with the character and development pattern in the surrounding area.






Exhibit B: Ordinance 2022-33

AN ORDINANCE AMENDING SECTION 2.08 OF THE CACHE COUNTY CODE

- (A) WHEREAS, Cache County has an executive-council form of government, as described in Utah Code 17-52a-203, wherein the County Executive is the chief executive officer, and the County Council is the county legislative body; and
- (B) WHEREAS, the County Council has the powers, duties, and functions of a legislative body and the county executive has the powers, duties, and functions of an executive; and
- (C) WHEREAS, the power to appoint and to remove officers has been generally deemed an executive power; and
- (D) WHEREAS, The County Council respects the legitimate enumerated powers of the executive; and
- (E) WHEREAS, the County Council may pass all ordinances and rules and make all regulations, not repugnant to law, necessary for carrying into effect or discharging its powers and duties; and
- (F) WHEREAS, the County Council has an interest in maintaining long term institutional expertise and knowledge within the several County departments; and
- (G) WHEREAS; the proposed regulations and processes do not interfere with the County Executive's appointment, suspension and removal powers of appointed department heads;

NOW, THEREFORE, the County Legislative Body of Cache County ordains as follows:

SECTION 1:

Section 2.08.060 of the Cache County Code is amended to read in full as follows:

2.08.060: GENERAL ADMINISTRATION:

A. Except where otherwise provided in this title or by the County Council, the County Executive shall appoint all officers and heads of departments upon the advice and consent of the County Council, the same being approved by the affirmative vote of four (4) council members.

B. Appointed Department Heads serve at the pleasure of the County Executive, in an exempt position, under Cache County Code 2.60.010. The County Executive may suspend or terminate the employment of a Department Head at any time for cause consistent with the Cache County Personnel Policy and Procedure Manual. Department Heads who have been employed by Cache



County for less than six months may be suspended or terminated by the County Executive at any time without cause.

- C. The Cache County Executive may remove an appointed Department Head from their Department Head position at any time. However, if the County Executive removes a Department Head from their position for any reason except for cause, the Department Head will be relieved of their duties to formulate and execute Department policy, supervise, manage, or direct the business affairs of their department, but the removed Department Head shall then convert to a classified employee under 2.60.010 retaining their salary and benefits at the same rate they received as a Department Head and shall be assigned work within their current department or within another County department that reports to the County Executive for which they are qualified to perform the duties.
- D. A Department Head removed from their position without cause may choose to receive severance instead of converting to a classified employee. The severance pay shall be six months of their salary. Department heads who have been employed more than 10 years shall receive an additional week's severance pay for each year above 10 years that they have been employed at the County.
- E. A Department Head shall only be suspended consistent with the Performance Improvement Policy set forth in the Cache County Personal Policy and Procedure Manual. The policy shall be approved by the County Council.
- F. When the County Executive removes a Department Head from their position consistent with this part or terminates a Department Head for cause, the County Executive or his designee shall, at the next scheduled meeting of the County Council, inform the Council of the removal, suspension, or termination and provide an explanation for the removal, suspension, or termination. If the County Executive's explanation involves the character, professional competence, or physical or mental health of the Department Head, such explanation and discussion shall take place in a closed meeting, consistent with Utah Code § 52-4-205 (1)(a).
- G. Nothing in this part shall be interpreted to give the County Council authority to advise and consent to, or veto, the County Executive's removal of a Department Head, nor the County Executive's suspension or termination of a Department Head for cause.

SECTION 2:

This ordinance takes effect 15 days following its passage and approval by the County Council.

2.08.060: GENERAL ADMINISTRATION:

A. Except where otherwise provided in this title or by the County Council, the County Executive shall appoint all officers and heads of departments upon the advice and consent of the County Council, the same being approved by the affirmative vote of four (4) council members.

B. Appointed Department Heads serve at the pleasure of the County Executive, in an exempt position, under Cache County Code 2.60.010. The County Executive may suspend or terminate the employment of a Department Head at any time for cause consistent with the Cache County Personnel Policy and Procedure Manual. Department Heads who have been employed by Cache County for less than six months may be suspended or terminated by the County Executive at any time without cause.

C. The Cache County Executive may remove an appointed Department head from their Department Head position at any time. If the County Executive removes a Department Head from their position for any reason except for cause, the Department Head will be relieved of their duties to formulate and execute Department policy, supervise, manage, or direct the business affairs of their department, but the removed Department Head shall then convert to a classified employee under 2.60.010 retaining their salary and benefits at the same rate they received as a Department Head and shall be assigned work within their current department or within another County department that reports to the County Executive for which they are qualified to perform the duties.

D. A Department Head removed from their position without cause may choose to receive severance instead of converting to a classified employee. The severance pay shall be six months of their salary. Department heads who have been employed more than 10 years shall receive an additional week's severance pay for each year above 10 years that they have been employed at the County.

E. A Department Head shall only be suspended consistent with the Performance Improvement Policy set forth in the Cache County Personal Policy and Procedure Manual. The policy shall be approved by the County Council.



F. When the County Executive removes a Department Head from their position consistent with this part or terminates a Department Head for cause, the County Executive or his designee shall, at the next scheduled meeting of the County Council, inform the Council of the removal, suspension, or termination and provide an explanation for the removal, suspension, or termination. If the County Executive's explanation involves the character, professional competence, or physical or mental health of the Department Head, such explanation and discussion shall take place in a closed meeting, consistent with Utah Code § 52-4-205 (1)(a).

G. Nothing in this part shall be interpreted to give the County Council authority to advise and consent to, or veto, the County Executive's removal of a Department Head, nor the County Executive's suspension or termination of a Department Head for cause.

A RESOLUTION ESTABLISHING A COUNCIL SPECIAL AUDIT COMMITTEE

WHEREAS, County Code enables the County Council to "establish and define the duties and functions of appointed boards and commissions deemed appropriate to expedite and facilitate the duties of the council" (Cache County Code 2.12.120H); and

WHEREAS, State Code empowers the County Council to "examine and audit the accounts of all county officers having the care, management, collection, or distribution of money belonging to the county, appropriated to the county, or otherwise available for the county's use and benefit" (Title 17, Chapter 53, Section 106(2)(a)(iii), Utah Code Annotated, 1953, as amended); and

WHEREAS, State Code also empowers the County Council to "investigate any matter pertaining to a county officer or to the county or its business or affairs" (Title 17, Chapter 53, Section 106(2)(a)(iv), Utah Code Annotated, 1953, as amended); and

WHEREAS, the County Council provides for an annual audit but may also provide for a special audit of accounts to be made (County Code 2.12.120G); and

WHEREAS, the County Council has deemed it necessary to conduct a special audit; and

WHEREAS, assigning a committee to coordinate and oversee the audit will allow the Council to focus on its regular duties, provide for continuity, and ensure the proper completion of the audit;

NOW, THEREFORE, be it resolved that the Cache County Council establishes the following:

CACHE COUNTY COUNCIL SPECIAL AUDIT COMMITTEE

1. DUTIES

The Special Audit Committee shall work closely with the external auditors, including reviewing auditing approaches, coordinating the audit, and directing the external auditors. Committee members shall have access to County information as requested. The committee shall maintain communication with and report to the Council Chair. When the audit is complete, the committee will review the audit and help the County Council interpret and understand the report.

2. MEMBERSHIP

The committee shall consist of two to three members appointed by the County Council. Term of office shall be two years. The term may be extended by the County Council. Members shall be removed for cause, by a majority vote of the Council.



3. MEETING SCHEDULE

The committee meets as needed to fulfill its responsibilities, but shall meet at least quarterly. The committee shall meet privately in order to discuss matters that should not be disclosed as part of the audit effort.

4. COMPENSATION

This is a volunteer committee without compensation.
