THE CACHE COUNTY COUNCIL MEETING MINUTES

March 28, 1995

The Cache County Council met in regular session on the 28th day of March, 1995 in the County Council Chambers located at 120 North 100 West, Logan, Utah 84321.

ATTENDANCE

Council members present: Chairman Sarah Ann Skanchy, Council members Guy Ray Pulsipher, Layne M. Beck, H Craig Petersen, Jerry L. Allen, Darrel L. Gibbons. Vice Chairman C. Larry Anhder arrived late.

Others present: Cache County Executive M. Lynn Lemon; Cache County Clerk Stephen M. Erickson; Cache County Attorney Scott Wyatt; Cache County Auditor Tamra Stones; Cache County Assessor Kathleen C. Howell; Cache County Treasurer Karen A. Jeppesen; Cache County Sheriff Sidney P. Groll; Cache County Planning & Zoning Administrator Lorene Greenhalgh; Cache County Senior Citizen Director Marcee L. Cazier; The Chairman of the Library Foundation Miles Jensen; Representatives of the local news media and other interested citizens.

CALL TO ORDER

Council Chairman Sarah Ann Skanchy called the meeting to order at 5:00 p.m. and welcomed all who were in attendance.

INVOCATION

The invocation was given by Councilman Jerry L. Allen.

AGENDA & MINUTES

The agenda for the meeting was adjusted and approved.

The minutes of the Special Council meeting held on March 8, 1995 and the minutes of the regular Council meeting held on March 14, 1995 and sent to all members of the Council were corrected and approved.

REPORT OF THE COUNTY EXECUTIVE

The County Executive M. Lynn Lemon reported on the following items:

1. Appointment:

The following individual was presented to the Council for appointment approval.

Appointment: Godderidge, Bruce H. Planning Commission

- A motion to approve the appointment was made by Councilman Petersen. It was properly seconded and carried unanimously. (Vice Chairman Anhder absent)
 - 2. Appeal Findings: Providence City, Pulver & Fisher.

Executive Lemon read the prepared findings concerning his decision on the appeal from Providence City & Dr's Pulver & Fisher.

The appeal was denied effective on March 28, 1995.

- 3. E. A. Miller, Hyrum City meeting: Lemon will represent the County at a special meeting between E. A. Miller and Hyrum City. An agreement has been drafted by E. A. Millers Attorneys for discussion and review.
- 4. UDOT Letter: A letter has been received from UDOT asking for county input on a bridge reconstruction project over Logan River in the mouth of Logan Canyon. Council members were invited to attend. Lemon will represent the County at the hearing.
- 5. Health Insurance & Workmans Compensation: There has been a 2% reduction in the Health Insurance premium but the Workmans compensation has increased. The premium for each will probably off-set each other.
- 6. Warrant Register: The Warrant Register was presented to the County Clerk for filing.

Chairman Skanchy read a Proclamation that if adopted would set dates in the county for a Statewide recycling of household appliances. The Proclamation also sets a date for disposal of household hazardous waste.

BUDGETARY MATTERS

PUBLIC HEARING: BUDGET OPENING-1995

The scheduled public hearing to receive input and to discuss proposed changes in the 1995 budget was convened at 5:30 p.m. by County Auditor Tamra Stones reviewed the Chairman Skanchy. proposed changes in revenue and expenses in the 1995 budget. County Assessor Kathleen Howell was asked to explain her requested budget increases. Howell said that the county's top appraiser has left the county, creating additional work load on the others in the department. And the necessity to send a new appraiser to school. Her department also is requesting an updated printer to better copy two sided documents. Howell was asked about the work load in her She compared our county with Washington County. office? Washington County has less parcels of property and less citizens and they have 15 employees to our 6. Howell said the mandate from the state to reappraise all property every five years, really adds to the work load. She will be requesting additional help later on this year.

The County Treasurer Karen Jeppesen told the Council that her computers need upgrading to 486 units. Mike Nilson, the Chairman of the County Data Processing Committee defended the request from the Data Processing Department to buy a high tech computer. The County Executive M. Lynn Lemon is recommending the approval of all the budget changes.

Chairman Skanchy asked for further comment from the public. Their were no further comments made.

A motion to close the public hearing was made by Vice Chairman Anhder. It was properly seconded and carried unanimously.

RESOLUTION NO. 95-11: BUDGET ADJUSTMENT-1995

The adoption of Resolution No. 95-11 will increase budget and appropriations in certain County Departments.

A motion to adopt Resolution 95-11 was made by Councilman Gibbons. It was seconded and carried unanimously.

THE COUNCIL ADJOURNED FROM THE REGULAR COUNCIL MEETING INTO A BOARD OF EQUALIZATION

BOARD OF EQUALIZATION: PROPERTY TAX EXEMPTION REQUESTS

The Board of Equalization discussed and acted on the following tax exempt requests:

- 1. Logan Regional Hospital: The Hospital is requesting 100% exemption on the building and land and 20% on personal property. There was some question on the application because there wasn't enough information.
- A motion to table the Hospitals request until further information is available was made by Board member Allen. It was seconded and carried unanimously.
- 2. Space Dymanic Laboratory: The County Assessor Kathleen Howell reviewed the building and the location of the building with the Board. Auditor Stones said that last year the request was granted for educational purposes. There was some concern about the request not meeting the necessary requirements for education because of a possible operation for profit. Councilman Petersen told the Council that a number of students further their education at the facility and it definitely qualifies under the education requirements for tax exemption.

A motion to approve the request was made by Board member Allen. It was properly second and carried unanimously.

3. Chamber of Commerce:

Board Chairman Skanchy told the Board that a subcommittee has met with the Chamber during the past week and have reviewed their application. It was determined that some areas of the building should be exempt because they meet the necessary requirements. The area that the Daughters of the Utah Pioneers and the area where operations for the Spendlove Research takes place qualify for exemption. The County Attorney Scott Wyatt told the Council that his office has reviewed the contract between the County and the Chamber of Commerce on the property exchange. Wyatt said that even though the feeling seemed to be in the contract to grant exemption nothing was in writing. He said that it would not be legal to have a contract that would allow exemption because of binding tax laws that may change from time to time.

A motion to deny the Chambers application was made by Board member Allen. It was properly seconded and carried unanimously.

Board member Anhder moved to amend the motion to give back to the Chamber any tax collected. Anhder feels that the Chamber does a lot for the County and would use the money to better the county.

After discussing the amendment it was determined that it would not be legal to return any tax money collected from the Chamber or anyone else in the same position. Anhder withdrew his amendment.

A motion to exempt the Daughters of the Utah Pioneers portion in the chamber building was made by Board member Allen. It was seconded and carried unanimously.

A motion to exempt the Spendlove Research portion was made by Board member Gibbons. It was seconded and carried unanimously.

THE BOARD OF EQUALIZATION ADJOURNED FROM THE BOARD MEETING BACK INTO THE REGULAR COUNCIL MEETING.

COUNTYWIDE LIBRARY: MILES JENSEN

The Chairman of the County Library Foundation Miles Jensen appeared before the Council to discuss a proposed Resolution that would create a Countywide Library System. Jensen said that due to SB 254 his committee is not ready to bring the Resolution back to the Council for a second reading. They would like the Council to keep it on the table and bring it back when the committee is ready. County Clerk Erickson was asked to review his memo concerning an election on the Countywide Library System. Erickson presented his memo to the Council.

CRAIG L. PINDER: Mr. Pinder, from Young Ward, expressed concern about the proposed Library System. He favors the system but would like more information as to what the cost will be and the location of the buildings etc. before an election takes place.

COUNTY WELL PERMIT-NIBLEY CITY: DISCUSSION

Executive M. Lynn Lemon is proposing that the County give a well permit to Nibley City if they will release the County from any responsibility that may occur because of gravel excavation near Nibley City's water springs. Attorney Wyatt said that if an agreement is signed we will not have to worry about extending the well permit again and we will not have any responsibility providing water to Nibley City because of gravel excavation.

A motion to release the well permit to Nibley City and authorize the County Executive to execute an agreement with Nibley City was made by Vice Chairman Anhder. It was properly seconded and carried unanimously.

CULINARY WATER: NIELSEN LETTER

Joseph S. Nielsen, a citizen of Logan, has sent a letter to the Council and the County Executive expressing his concerns about allowing the development of a seven lot subdivision near Paradise and culinary water needed for the development.

The Planning and Zoning Administrator Lorene Greenhalgh told the Council that there hasn't been a home built in the county where

water has been a problem. There has always been enough water for a family to move into their home. Executive Lemon said that the State Engineer is requiring the County to have a Water Management Plan before any large well permits are issued. Lemon will send the letter to the County Water Policy Board and he recommends that we wait for their recommendation concerning the issue. Lemon will draft a reply to the Nielsen letter.

PLANNING DISTRICT: DISCUSSION

A Memo from the County Planning Administrator Lorene Greenhalgh was discussed by the Council. The Planning Commission is recommending support for Planning Districts in the County as proposed by the Countywide Planner, Mark Tuescher.

SENIOR CITIZEN KITCHEN FUNDING : MARCEE CAZIER

The Director of the Senior Citizen Center Marcee Cazier reported to the Council that they would like to begin construction of a new kitchen in the Center. They have received a multi year CDBG and want to use \$52,000.00 seed money from their fund balance to begin the project. The time frame for the project was discussed along with various fund raising projects such as 3 on 3 basketball games and a quilt a month program.

A motion to allow the use of the fund balance was made by Councilman Allen. It was properly seconded and carried unanimously.

Wesley Maughan was introduced as the project manager.

JAIL PROGRAM OFFICE REQUEST: SIDNEY P. GROLL

The County Sheriff Sidney P. Groll met with the Council again to request a new position in the Jail Department. Groll said that funding is in place to hire a Jail Program Officer. Funds that are coming from the state prisoner reimbursement program and are only allocated on request, by the County, are dedicated for jail related programs. The expected amount of \$70,000 to \$90,000 this year is more than enough to fund the new position. The County Executive M. Lynn Lemon is recommending that the new position should be funded.

A motion to approve the position of a Jail Program Officer was made by councilman Gibbons. It was seconded and carried unanimously.

Fast Cops grants were discussed by the Council. Sheriff Groll said the grants are for three years. Those communities who have received the grants are aware that they are only for three years and at the end of three years the communities are to pickup the funding for the new officers.

COUNTYWIDE PLANNING WORKSHOP: SCHEDULED

A workshop to discuss efforts of the Countywide planner will be held on March 29, 1995. Council members were encouraged to attend.

FOREST SERVICE: STUDY AREAS

Chairman Skanchy appraised the Council of the studies presently being done by the Forest Service. Executive Lemon was asked to draft a statement to the Forest Service concerning what they are proposing. They are proposing some changes at the Tony Grove area, updating the list of noxious weeds and are studying range land use and grazing management.

PARADE: SMITHFIELD HEALTH DAYS

Council members were invited to ride in the Smithfield Health Days parade on May 13, 1995 at 10:00 a.m.

COUNCIL MEMBER REPORTS

Councilman Allen: Reported that he attended the BRAG meeting in Brigham City. Allen asked what the Westons were doing about their sign. Executive Lemon said that they have applied for a permit and are continuing to meet the requirements set by the Council. Councilman Allen also expressed concern about signs on the Logan City Fire Trucks. He said that the county's name is on the back and Logan City's name is on the sides. Councilman Allen rported that the tower at the airport is in need of repair and something should be done to bring it up to standard.

Councilman Petersen: Asked when the Restaurant Tax allocation will take place. He was told that usually the second meeting in May. Petersen requested that the President of USU, George Emert, be invited to meet with the Council.

Councilman Pulsipher: Requested that the fence issue at the fairgrounds be put on a future agenda. Pulsipher expressed concern that some large trucks are creating problems on roads in his area. Apparently they are going up impassable roads and are unable to turn around. It was suggested that some directional signs be installed.

ADJOURNMENT

No further business was presented for discussion or action. This meeting was adjourned by Chairman Skanchy at 7:50 p.m.

- 1. Celco, Inc. and/or Mr. Steve Oldfield has requested a conditional use permit to allow the building of a residential home on certain property located on the Providence Canyon Road East of Providence City boundaries.
- 2. The Cache County Planning Commission granted the conditional use permit to allow the residential home to be built on the subject property.
- Two appeals to the conditional use permit were filed. The first, by 3. Providence City and the second, jointly by Kerry Pulver and Laura Fisher. A public hearing was held on February 14, 1995, wherein, Providence City appeared through Paul Holden, Chairman of the Providence City Planning Commission. Laura Fisher was present and represented by Attorney Larry Jones; and Celco, Inc. was present and represented by Attorney Lauren M. Lambert. Cache County Executive, M. Lynn Lemon, heard the representations by each of the parties. The County Executive, Cache County, Utah, makes the following findings in the above designated appeal:

- 1. Celco, Inc. and/or Mr. Steve Oldfield has requested a conditional use permit to allow the building of a residential home on certain property located on the Providence Canyon Road East of Providence City boundaries.
- 2. The Cache County Planning Commission granted the conditional use permit to allow the residential home to be built on the subject property.
- Two appeals to the conditional use permit were filed. The first, by 3. Providence City and the second, jointly by Kerry Pulver and Laura Fisher. public hearing was held on February 14, 1995, wherein, Providence City appeared through Paul Holden, Chairman of the Providence City Planning Commission. Laura Fisher was present and represented by Attorney Larry Jones; and Celco, Inc. was present and represented by Attorney Lauren M. Lambert. Cache County Executive, M. Lynn Lemon, heard the representations by each of the parties. The Executive asked the parties for a written submission, which all parties submitted on or The Executive also reviewed the entire record before February 28, 1995. concerning this application created by the County Zoning Administrator, the County Planning Commission and the County Council. The entire record is incorporated herein. The Executive makes the following findings in the above designated appeal:

FINDINGS

- 1. The property is described as follows: part of Cache County Property ID Number's 02-116-0007 and 02-114-0014, also described as 1577 East Canyon Road, Providence, Utah.
- 2. The property is zoned Agricultural, which allows homes to be built if a conditional use permit is obtained.
- 3. Celco, Inc., as the owner of the property, and as the assignee of any interest Mr. Steve Oldfield has, has standing to seek this application.
- 4. The subject property is within Providence City's annexation declaration area and is included within its master plan. Providence City has indicated an interest in annexing the property.
- 5. Providence City Planning and Zoning Commission has, in the past, recommended to the City Council that the area be annexed to Providence City; however, the City has voted against the annexation.
- 6. The subject property appears to be a part of an area that may become a much larger subdivision. The Cache County Land Use Ordinance defines a subdivision as "the division of a tract, lot or parcel of land into three or more lots." This lot constitutes the second parcel. As soon as a third parcel is created Celco, Inc. must comply with subdivision requirements, but it is not obligated to do so at this point.
- 7. Providence City has maintained that it will have an absolute obligation to provide services to this lot if the County allows the conditional use permit. This is not accurate as Providence City has no legal obligation to

provide services to any lot outside its boundaries. Providence City may choose to contract with any person building on this lot but has no obligation to do so. It is noted however, that, Providence City has agreed to provide services to adjoining lots outside Providence City boundaries.

- 8. If the subject property was located within Providence City the size of the lot meets or exceeds what would be required by Providence City for the bordering zone. Further, within the last two years, Providence City has allowed several homes to be built within a very short distance of this proposed home.
- 9. The subject property is East of the deer fence. The fact that the subject property is East of the deer fence is not dispositive for a determination as to whether a building permit could or should be issued for the subject lot. The deer fence is not contemplated in the County Land Use Ordinance; the zone, within which the subject property lies is the relevant enquiry. The subject property is contained within the agricultural zone, and must be treated consistent with all other lots in the agricultural zone.
- 10. It has been suggested that granting a conditional use permit is improper as the required notice has not been given to all required adjoining land owners. Appendix B IV -8.1 of the Cache County Land Use Ordinance requires "The Planning Commission, through its staff, shall, insofar as practical, notify by mail all property owners appearing on the latest plat in the Cache County Recorder's office within 300 foot radius of the property for which a conditional use permit or zoning amendment is requested." It further states "The above information shall be furnished to the Planning staff by the applicant. Compliance with this subparagraph shall not be a condition precedent to proper

legal notice and no hearing or action taken thereon shall be deemed invalid or illegal because of the failure to mail the notices provided for in this paragraph." It is found, however, that all property owners within a 300 foot radius of the property, if they did not receive notice as indicated above, did in fact receive actual notice and were aware of all proceedings and had full opportunity to provide input to this appeal.

- 11. Based on the written representations to the County Zoning Office by the Spring Creek Water Users Association, the applicant is capable of satisfying and mitigating any concerns that might endanger waterways and wetland needs.
- 12. Laura Fisher and Kerry Pulver have a well located on their property adjacent to the subject property and have expressed concerns that, although they are not currently using the well for culinary water uses, may in fact choose to use it for that purpose in the future. Based on written representations made to the County Zoning Office by the Bear River Health Department, the Executive is satisfied that Celco, Inc. can mitigate any potential harm to the well located on the Pulver/Fisher property.
- 13. With respect to the sensitive area requirements in the Cache County Land Use Ordinance, the Executive is satisfied that through the representations of applicant any concerns can and will be mitigated.
- 14. The Planning Commission rated the subject property according to rating guidelines at a minus 45. This is not a barrier to a proposed use and was not a barrier to the Planning Commission recommending issuance of the conditional use permit. Appendix E of the Cache County Land Use Ordinance provides "Section 23-5.A states that the Planning Commission may establish criteria for the

consideration of any matters to be brought before the board. No particular point total is mandatory for approval or denial." The point system is not dispositive but rather instructive in determining whether or not a permit should be issued. The point system may have an impact on the required mitigation. Based on written representations made to the Planning Commission by Christensen Engineering, The Executive is satisfied that a safe home can be constructed on the steep slop and fault area. The Executive is also satisfied that the conditions set forth by the Planning Commission will adequately address the problems that led to the Planning Department's rating. Further, the Executive concludes that the proposed mitigation and studies provided by applicant are adequate to address any and all concerns associated with the subject property.

- 15. The Executive further finds that granting a conditional use permit to allow applicant to build a single family dwelling unit on the subject property is reasonable and necessary for the public convenience, necessity, welfare and safety based on the following:
 - a. The request is reasonable and reasonably necessary to the applicant and the beneficial use of his property.
 - b. The request is not inconsistent with the general purpose of the zone. The county's agricultural zone specifically allows for the use requested.
 - c. The home would not create nor unreasonably increase hazards or dangers to adjacent property owners or to the community because of a resulting fire, explosion, pollution, increase traffic congestions, increase parking, or from the presence of any

dangerous conditions or materials, more than any other use permitted in the zone.

d. An injustice would result if a conditional use permit for this home where not granted, as the applicant would be hampered in his ability to make valuable use of the property.

ORDER

Based on the foregoing the Cache County Executive orders that:

- 1. Appellant, Providence City and Kerry Pulver and Laura Fisher's appeals are hereby denied.

Dear County Government Officials,

I wish to express some concerns about the "Field of Dreams" subdivision, north of Paradise, Utah, and problems with culinary water.

Facts:

- The seven lot "Field of Dreams" subdivision was approved by the County with culinary water appropriations for only two homes.
- Five building permits have been issued (four of those are now occupied) in the subdivision with only water appropriations for two families.
- The Cache County Zoning Administrator is representing that subdivision approval is granted for Residential Subdivisions when there are applications for culinary water (no actual appropriations are required), and in this case, only applications for two of seven lots.
- Some of the owners of the lots have applied for water appropriations. However, these applications are pending a water study by the State Engineer to determine if there is any water to appropriate.
- 5. My family owns property in the area. This property has several free flowing springs and the development of wells is affecting the amount of appropriated water in our springs.

Problems:

What happens if the State Engineer denies the appropriation of additional water for the subdivision? Or if the appropriations are approved and at a later time found to conflict with existing water rights and thus the wells shut down? Since the County approved the subdivision and issued building permits, 2 will the County be required to furnish water for the subdivision? Or what other liabilities are faced by the County because of thi subdivision and actions of County employees?

Since the County will be around longer and has more financial resources that the subdivider, it seems to me that there is substantial liability to the county from property owners in the subdivision, lenders, and other water rights in the area.

Corrective Actions:

1. Limit County liability by requiring actual water appropriations for a fully developed subdivision, (not just applications or partial appropriations), before approval is granted.

2. Limit County liability by requiring proof of culinary water for residences before a building permit is issued. includes having a well or water source completed and the water appropriated by the State Engineer.

3. Limit County liability by having development stop in the

"Field of Dreams" subdivision until this issue can be solved.

4. Correct the Zoning and Subdivision laws, if needed, to implement the above corrective actions (#1 and #2).

I look forward and expect a response to this problem.
