The Cache County Council met in a special session on the 29th day of October, 1996 in the Council Chambers at 120 North 100 West, Logan, Utah 84321.

#### ATTENDANCE

# CACHE COUNTY RESOLUTION NO. 96-34

A RESOLUTION OF THE CACHE COUNTY COUNCIL TO EXTEND SUPPORT TO LOGAN CITY FOR THE CITY'S WILLINGNESS TO ACCEPT THE RESPONSIBILITY TO ADMINISTER THE CENTRALIZED COMMUNICATION AND DISPATCH NEEDS FOR THE COUNTY.

WHEREAS: Pursuant to a Management Agreement dated the 14th day of August, 1992, Cache County has undertaken the responsibility to manage the centralized communication and dispatch needs of the various public agencies serving the communities and people of Cache County.

WHEREAS: This Management Agreement, referred to above, terminated on the 14th day of August, 1996; however the County was willing to continue managing the centralized communication and dispatch needs until other administrative agreements could be established.

WHEREAS: The City of Logan has expressed a willingness to manage the centralized communication and dispatch needs as a new department in the City administration.

WHEREAS: The County believes that the centralized communication and dispatch needs can be more efficiently and effectively managed as a department within Logan City rather than as a separate entity overseen by a Governing Board and an Operations Board and managed through a Management Agreement with another entity.

THEREFORE BE IT RESOLVED BY THE CACHE COUNTY COUNCIL, STATE OF UTAH, AS FOLLOWS:

That Cache County support the City of Logan in its willingness and efforts to manage the centralized communication and dispatch needs beginning on January 1, 1997.

This resolution was adopted by the Cache County Council in a regular meeting, lawful notice of which has been given, this 29th day of October, 1996.

# Joint Resolution of the CACHE COUNTY COUNCIL and the LOGAN MUNICIPAL COUNCIL

Resolution No. 96-35

A JOINT RESOLUTION OF THE CACHE COUNTY COUNCIL AND THE LOGAN MUNICIPAL COUNCIL (COLLECTIVELY REFERRED TO HEREINAFTER AS THE "PARTIES") TO TERMINATE THE INTERLOCAL AGREEMENT DATED THE 23RD DAY OF MAY 1991 RELATIVE TO THE CACHE VALLEY COMMUNICATIONS CENTER (REFERRED TO HEREINAFTER AS THE "CENTER") AND, PURSUANT TO SECTION 4(a)(2) OF THAT AGREEMENT, TERMINATE THE CENTER.

### RECITALS

- A. By resolution no. 91-12 passed by the Cache County Council on the 28th day of May, 1991 and by resolution no. 91-47 passed by the Logan Municipal Council on the 20th day of June, 1991, the parties each declared the desirability of creating a centralized communication and dispatch center to meet the needs of the various public agencies serving the communities and people of Cache County including law enforcement, fire protection, emergency medical, and other areas of public safety. These two resolutions further authorized the parties' respective executive officers to execute an interlocal agreement for the creation and administration of the Center.
- B. On the 23rd day of May, 1991, Cache County Executive, Seth S. Allen, and Logan City Mayor, Russell F. Fjeldsted, executed an interlocal agreement for the parties to create and provide for the administration of the Center.
- C. On the 14th day of August, 1992, Cache County Executive, Seth S, Allen, for Cache County, Chairman of the Center's Governing Board, Seth S. Allen, for the Center, and Chairman of the Center's Operations Board, Sidney P. Groll, for the Center, executed a Management Agreement wherein Cache County was designated the managing agency of the Center for a period of four years.
- D. On the 14th day of August, 1996, the Management Agreement, referred to above in Paragraph "C," expired.
- E. Prior to and following the expiration of the Management Agreement, referred to above in paragraph "C," the parties engaged in discussions regarding the continuation of the Center and regarding the most effective and efficient manner in which centralized communication and dispatch needs could be administratered.

NOW THEREFORE, the Cache County Council and the Logan Municipal Council jointly resolve as follows:

# SECTION 1: DECLARATION OF NEED.

There is hereby declared a continuing need for participation by the parties in centralized communications and dispatch needs.

# SECTION 2: ADMINISTRATION OF CENTRALIZED COMMUNICATIONS AND DISPATCH NEEDS.

It is agreed that Logan City will manage the centralized communications and dispatch needs by creating a new department within the City administration rather than continuing the existence of the Center as a separate entity. The parties will create and execute interlocal agreements wherein Logan City will act as contractor in providing the centralized communications and dispatch needs for the benefit of the communities and people in Cache County.

# SECTION 3: DISSOLUTION OF CENTER.

The Cache Valley Communications Center is hereby terminated effective midnight at the end of the 31st day of December, 1996. This termination is contingent upon the interlocal agreements between the parties referred to above in Section "2" being executed by the effective date referred to in this section.

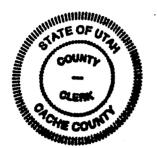
## SECTION 4: ASSESSMENT.

The joint resolution does not modify or alter the present assessment for the centralized communications and dispatch needs except that the funds will be made available to Logan City for purposes of administering the same rather than to Cache County.

## SECTION 5: EFFECTIVE DATE.

This resolution shall be effective immediately upon adoption by both parties.
