CACHE COUNTY COUNCIL MEETING MINUTES

April 27, 1999

The Cache County Council met in a regular session on April 27, 1999 in the County Council Chambers located at 120 North 100 West, Logan, Utah 84321.

ATTENDANCE

Council Chairman, Darrel L. Gibbons and Vice Chairman, H. Craig Petersen were present. Council members present were: Sarah Ann Skanchy, Layne M. Beck, Cory Yeates, Guy Ray Pulsipher and C. Larry Anhder.

Others present were: M. Lynn Lemon, County Executive, Stephen M. Erickson, County Clerk, Tamra Stones, County Auditor, Russ Akina, Logan City Parks and Recreation Director, members of the local news media and other interested citizens.

CALL TO ORDER

Chairman Darrel L. Gibbons, called the meeting to order at 5:00 p.m. and welcomed all who were in attendance.

INVOCATION

The invocation was given by Council member Sarah Ann Skanchy.

AGENDA AND MINUTES

The agenda for the meeting was discussed and amended to delete item 9b, a discussion on the ambulance fund. The agenda was then approved without any further adjustment.

The minutes of the Council meeting held on April 13, 1999 were reviewed, discussed, corrected and approved.

REPORT OF THE COUNTY EXECUTIVE

The County Executive reported on the following items:

1. North American Weather Consultants Final Report: Lemon reported that a final report on weather modification by North American Weather has been received. They are reporting that at the end of February we were 107% of normal and at the first of April we will be near 95% of

normal. They mentioned that during the month of March there wasn't as many storms to cloud seed.

- 2. American West Heritage Foundation: The first tour group to their facility has been scheduled.
- 3. Forest Service Plan Revision: Meetings will be held on April 29, 1999 at the Logan Ranger Office at 6:00 p m and 7:00 p.m. to receive input on a revision of the Forest Plan. Council members were advised that supportive materials regarding the meetings will be in the County Executives Office for review.
- 4. Logan Canyon Highway Improvements Meeting: A meeting on improvements to the Logan Canyon Highway will be held in the Logan City east meeting room. The workshop will be held on April 28, 1999 from 4:00 p.m. to 7:00 p.m.. Council members were encouraged to attend.
- 5. Cornish Gravel Pit: Council members were informed in a letter about the concerns of the Cornish gravel pit.
- 6. Restaurant Tax Requests & Prior Allocations: A list of requests for Restaurant Tax from different entities, also showing prior allocations was presented to the Council. Executive Lemon will make recommended allocations for presentation to the Council in a future meeting. Applications were presented to the Council for review.
- 7. Warrants: The County Warrants for the periods of April 8 to April 19, April 20 to April 23 and April 24 to April 27, 1999 were presented to the County Clerk for filing.

RESOLUTION NO. 99-09: BUDGET REDUCTION-1999

The County Auditor, Tamra Stones was asked by Chairman Gibbons to review Resolution No. 99-09. The adoption of the resolution will adjust revenues and expenditures to the 1999 County General Budget. This particular adjustment will reduce the 1999 budget.

A motion to adopt Resolution No. 99-09 was made by Councilman Yeates. It was seconded and carried unanimously.

PUBLIC HEARING: MILLER E. J. - AGRICULTURAL PROTECTION AREA

The E. J. Miller Real Estate Trust has applied to establish an Agricultural Protection on some of their property North of Hyrum. A Public Hearing is necessary and is scheduled for May 11, 1999 at 6:00 p.m. in the County Council Chambers.

PUBLIC HEARING: JENSEN, CORDELL O AND DONA- AG. PROTECTION AREA

Cordell and Dona Jensen, from Logan, has applied to establish Agricultural Protection area on their property. A Public Hearing is necessary and is scheduled for May 11, 1999 at 6:00 p.m. in the County Council Chambers.

A motion to set the two above, mentioned Public Hearings was made by Councilman Beck. It was properly seconded and carried unanimously.

BOARD OF EQUALIZATION

The Council adjourned from the regular Council meeting into a Board of Equalization.

TAX EXEMPTION REQUEST: STOKES NATURE CENTER

The County Auditor, Tamra Stones, reviewed a Tax Exemption application requesting that the Allen & Alice Stokes Nature Center be exempt from property tax for educational purposes.

Councilman Pulsipher moved to approve the request. It was seconded and carried unanimously.

IHC HOSPITAL: TAX, PROPERTY EXEMPTION FACT FINDINGS

The Board of Equalization reviewed a memo from Council member Skanchy regarding a meeting that was held with elected County Officials and Officials from IHC (Logan Regional Hospital). The meeting was held to discuss their Tax exemption request. Findings and facts on the application were also reviewed.

A motion to approve and accept the Findings, was made by Board member Skanchy. It was properly seconded and carried unanimously.



WILLOW PARK DEVELOPMENT: AKINA, RUSS

Russ Akina, the Director of the Logan City Parks and Recreation Department was to report to the Council on Willow Park matters. However, the Willow Park Advisory Board was unable to meet last week to review the proposed budget, the revised inter-local agreement and recommendation for the West Property. The Board will meet on April 29, 1999 and Akina will again meet with the Council at their next meeting.

WATER POLICY: DISCUSSION

Since the defeat of the proposed Water Conservancy District during an election on February 2, 1999, the Council is now faced with the dilemma of what to do regarding water issues in the County. In a previous meeting where the public was asked to respond to the matter it was determined that all concerned groups should send written comments to the Council for review. Written statements or comments have been received from the People for Wise Water, North & South Cache Soil Conservation Districts, the County Farm Bureau and the County's own appointed Water Policy Advisory Board. Councilman Anhder who serves as chairman of the County Water Policy Advisory Board was asked by Chairman Gibbons to discuss the Board's written statement.

Anhder, reviewed the Boards Mission Statement, the Boards Priorities, action items for implementation, budgeting and staffing. Anhder, also mentioned the possibility of pumping water into the ground for storage. Pumping water back into the ground is already being done in certain areas of the country.

Chairman Gibbons, said that all the written comments from the representative groups were favorable to doing something to manage our water. Now the Council has to decide what and how to manage water in the County. Do we create a County Water Department, combine water with some other department, what kind of a budget would be necessary to operate the department and what should be the make up or composition of a water advisory board?

Anhder, was asked if the Advisory Boards budget recommendation of \$285,000.00 to fund a Water Department could be reduced? Anhder, said that if some of the proposed studies are not scheduled for the present, it may be possible to get started for \$150,000.00. This would also cut the staff in half. Councilman Beck suggested that water management be structured through and with the County-Wide Planning office and he suggested that, Cities have more representatives on the Board. Councilman Petersen suggested that the budget be \$50,000.00 and as each study or project comes along they could be funded separate.

COUNCIL MEETING MINUTES 04/27/99

The Council discussed the Boards composition, making suggestions that may serve water management better. Councilman Petersen suggested that the Board have less, members with more expertise. Anhder, said that the Board has recommended 11 members representing, Agriculture, County, Municipalities and water experts etc. Petersen further stated that he does not want to raise taxes to fund a water department.

It was determined by the Council that a workshop should be scheduled to further study the issue. The workshop will be held at 3:30 p.m. on May 11, 1999.

FISCAL PROCEDURE ORDINANCE: DISCUSSION

It has been suggested by Councilman Petersen in earlier meetings that the dollar amount necessary to have Council approval for an intra-departmental transfer be increased to \$1000.00. This would eliminate the Council from having to act on every intra-departmental budget transfer that is less than \$1000.00. The County Auditor, Tamra Stones reminded the Council that the State law has also been changed to allow the suggested action. Executive Lemon, expressed his concern that the decision may create problems in some cases with him having the final say on the transfer. Lemon was told that he, if he desires, still could have the opportunity to bring any transfer before the Council for their approval.

Councilman Petersen moved to set the intra-departmental transfer limit at \$1000.00 before any action by the Council is necessary and to have the County Attorney's Office draft an amendment to the County Fiscal Procedure Ordinance allowing the procedure. The motion was seconded and carried unanimously.

ELECTED OFFICIALS AND DEPART. HEAD-JOINT MEETING: DISCUSSION

Chairman Gibbons, proposed a joint meeting between the Elected Officials and all County Department Heads. The meeting would be held to discuss issues and concerns surrounding the extensive growth in the County. Executive Lemon, said that he believes it would be a good idea and an agenda of priorities could be developed for discussion. It was determined that the meeting would be held on the fifth Tuesday in June.

COUNCIL MEMBER REPORTS

Chairman Gibbons reminded the Council of the Smithfield Health Days & Richmond Black & White Days parades on May 8th & 15th respectively.

Bear River Basin as of April 1, 1999

Snowpacks on the Bear River Basin are now near average at 95% of normal, down 9% relative to last month, very close to last year. Specific sites range from 56% to 122% of normal. March snowpack increase was only 38% of normal, but was the highest in the state. March precipitation was below normal at 74%, which brings the seasonal accumulation (Oct-Mar) to 98% of average. Reservoir storage is excellent at 78% capacity, with small reservoirs, except Porcupine which is under repair, essentially full. In general, water supply conditions are near average and a good water year is expected.

CACHE COUNTY WATER RESOURCES DEPARTMENT

MISSION STATEMENT:

The purpose of the department is to coordinate water resources planning and management to insure a safe, secure, economical supply of a sufficient quantity of water of adequate quality to meet the domestic, agricultural, environmental, and industrial needs of Cache County through the year 2050.

*Currently a part of the Cache County Countywide Comprehensive Plan Adopted January 27, 1998

PRIORITIES:

- 1. Protect existing water rights.
- 2. Insure that the 60,000 acre-feet/year of Bear River water legislatively apportioned to Cache County is available for use in Cache County.
- 3. Keep existing perfected water rights in Cache County as water uses change and transfers occur.
- 4. Protect (and improve as needed) the quality of surface and ground waters.*
- 5. Develop a regional storm water management plan.*
- 6. Protect and enhance natural and wildlife resources through coordinated management.*

ACTION ITEMS FOR PRIORITY IMPLEMENTATION:
