CACHE COUNTY COUNCIL MINUTES 27 February 2001

The Cache County Council met in a regular session on 27 February 2001 in the Cache County Council Chamber at 120 North 100 West, Logan Utah.

CALL TO ORDER:

Chairman Gibbons called the meeting to order at 5:03 p.m..

INVOCATION:

Council member Cory Yeates offered the invocation.

REVIEW AND APPROVAL OF AGENDA:

The agenda was approved as advertised.

REVIEW AND APPROVAL OF MINUTES:

The minutes of 13 February were discussed, corrected and approved.

REPORT OF COUNTY EXECUTIVE:

County Executive Lemon reported on the following:

1. Appointments:

There were no appointments.

- 2. Warrants: The County Warrants for the period of February 10th to 17th were presented to the County Clerk for filing.
- 3. Other Items: Executive Lemon discussed a request from the Committee representing People for a Nicer Cache County. They would like the County Council to pass a resolution placing one-tenth of one percent Sales Tax Initiative for Recreation, Arts, Parks, and Zoos on the next General Election ballot. This tax is also referred to as a ZAP tax. Executive Lemon said that this could possibly be placed on the General Election ballot in 2002.

COMMUNITY DEVELOPMENT BLOCK GRANT PUBLIC HEARING:

Executive Lemon, opened the second public hearing for the CDBG program. Executive Lemon stated that this hearing is being called to allow all citizens to provide input concerning the project which was awarded under the 2001-2002 Community Development Block Grant Program. The county has amended its capital investment plan and decided to apply for funds on behalf of the Citizens Against Physical & Sexual Abuse in Cache County. Executive Lemon explained that the application was successful in the regional rating and ranking process, and they will construct a shelter for Victims of Domestic Abuse. The Grant award amount is \$150,000.00. Executive Lemon explained the project to those in attendance. Executive Lemon then asked for any comments, questions and concerns from the audience. Executive Lemon stated that copies of the capital investment plan are available if anyone would like a copy. There were no comments and the hearing was adjourned at 5:18 p.m..

SENATOR ORRIN HATCH'S OFFICE: MARREEN CASPER

Marreen Casper with Senator Hatch's office appeared before the Council to introduce herself. She works with the Senator as his Director of Federal Grants. They would like all Counties to be aware of this position which was created to help with information about Federal Grants. Ms. Casper's direct line is (801)524-5555 in the Salt Lake office.

STATE TAX COMMISSION: LEE BRENNAN

Lee Brennan from the State Tax Commission introduced herself to the Council. Ms. Brennan will be in Cache County next week to meet with the County Assessor, Auditor, Treasurer and Recorder. She will be reviewing with these officials the best practices and procedures for collecting taxes. She will submit a report to the Council.

BOARD OF EQUALIZATION

The Council moved into a Board of Equalization.

A motion to approve the above DUP application was made by Board member Yeates. It was seconded by Board member Beck and carried unanimously.

A motion to approve the above First Presbyterian Church, American Red Cross, County Children's Justice Center, Whittier Community Center, Cache Valley Bible, Cache Valley Christian Center, Emmanuel Baptist Church, Full Gospel Fellowship, Harmony Lodge applications, was made by Board member Yeates. It was seconded by Board member Robison and carried unanimously.

A motion to approve the above Planned Parenthood application, was made by Board member Anhder. It was seconded by Board member Petersen and passed. 5 yes 2 no. Yeates and Beck voted no.

The Council adjourned from the Board of Equalization.

COUNCIL MEETING CONTINUED

THE PRUDENTIAL SPIRIT OF COMMUNITY AWARDS RECIPIENTS:

Chairman Gibbons recognized Marin Poole and Jennifer Conger who have received the State Prudential Spirit of Community Award. Ms. Conger helped a friend, Kami Ryan who was seriously burned. She helped her friend recover from her injuries. She has also volunteered her time at the Hospital. Ms. Poole has worked with Tobacco Advocacy for four years. She is on the Governor's Youth Council through Bear River Health Department. She has educated Elementary, Middle and High School students about the harmful effects of tobacco. Ms. Poole has lobbied for higher cigarette taxes and also lobbied for where the money should be spent from the Tobacco settlement.

Vice-Chairman Beck read a Proclamation honoring Jennifer Conger and Marin Poole on be half of Cache County.

Council member Petersen moved to approve the Proclamation. Council member Yeates seconded the motion and it carried unanimously.

REVIEW OF RESTAURANT TAX APPLICATION -2001:

Executive Lemon reviewed the Restaurant Tax application with the Council. Council member Petersen suggested changing the application deadline date to April 2, 2001 since the 1st of April falls on a Sunday. With no other changes the Executive will send the applications out the 1st of March 2001.

RESOLUTION NO. 2001-10 - Advisory Board for Restaurant Tax Allocations:

The Council discussed Resolution 2001-10 concerning an Advisory Board for Restaurant Tax Allocation. This board would assist and advise the Council in the allocation and use of the tax for the tourism, recreation, cultural and conventional facilities for Cache County. Council member Anhder suggested changing the number of Board members from 9 to 7, eliminating the County Executive and the Convention Facilities person from the board. Council member Anhder also would like the term of a board member extended to 4 years. There was no action taken on this resolution. It will be on the next agenda for a second reading.

AMBULANCE PROPOSAL: JEFF PETERSEN

Jeff Petersen came before the Council to discuss an ambulance proposal. Mr. Petersen sees two major goals in this proposal. 1. Find a funding mechanism to fund the ambulance County wide. 2. To build a system that meets the needs of the entire County today and also looks into the future. Mr. Petersen outlined three new ambulance locations. One at the new USU station on the corner of 10th North and 12th East. Another station around 18th South and Hwy. 89-91 and a third station to be located at the Logan/Cache Airport. Council member Anhder questioned what the cost would be? Mr. Petersen proposed a \$1.00 per garbage can-unit pickup fee. This fee would generate around \$340,000.00 annually. Council member Anhder also questioned possibly getting the funding from a property tax increase? Executive Lemon said that the Ambulance Committee had looked at both options for funding. Council member Beck questioned what would happen if the county and the city can't work out funding for the plan and it folds? Paul Patrick, the State Program Director for Medical Services, said by law the state would be forced to step in and devise a plan for service.

Chairman Gibbons would like to invite the County Elected Officials to meet with the County Council. He feels that this would give the Council an opportunity to become better acquainted with the different functions of the County offices. Council member Robison reviewed a proposal to place on the next Council agenda the creation of a Public Works Department and the possible division of the County Attorney's Office. Ms. Robison stated that since it might affect some elected official's office it needs to be known that any job change will not be related to the review process but may come about due to a change in County Government structure. Chairman Gibbons asked Attorney Wyatt for an opinion from his office. Attorney Wyatt's memorandum opinion is attachment #4 in the minutes. It was decided by the Council that Council members' Anhder and Hansen would meet with Jim Smith to go over some structured questions for the Elected Officials. These questions would be submitted to the Council for review.

This would allow \$60,143 to be put toward capital improvement/rolling stock annually. At this rate we would be able to buy a new ambulance every 2-3 years. This proposal would not allow for any funds to be put toward the construction of buildings.

If the rate could be increased to \$2 per unit this would allow \$230,143 to be put toward capital improvement/rolling stock annually. At this rate we would be able to buy a new ambulance every 2 years and allow roughly \$170,143 per year toward building station 72 at 1800 south area. At that rate we would be able to construct that facility in 4 years. After that station is constructed it would take virtually all of the money left each year to cover the operating costs.

An ambulance board would be formed to oversee the allocation of funds however, the day-to-day operations of station 70 downtown, 71 USU, 72 1800 south and 73 2500 north would be under the control of Logan Fire. As the program extends out into the county the operation of those stations would be under Cache County Fire.

REGARDING:

County Council Authority to Supervise Elected County Officers.

This office has been asked to address the question of whether the Cache County Council can exercise supervisory authority over elected county administrative officers. The short answer to the question is: the Council can.

U.C.A. section 17-5-213 provides, "[the county legislative body] may supervise the official conduct of all county officers and officers of all precincts, districts, and other subdivisions of the county (except municipal corporations); see that they faithfully perform their duties, direct prosecutions for delinquencies, and when necessary require them to renew their official bonds, make reports, and present their books and accounts for inspection."

Our Organic Act provides in section 3.13(c) that "members of the County Council shall not interfere in the administration of County affairs by the County Executive or other executive personnel."

The Utah Code empowers councils and commissions to supervise elected officials; our organic act prohibits individual council members from interfering with the officials' administration of County affairs. Appropriate supervision and control of salaries by the Council should not be considered "interference." It is this office's opinion that the Council has broad latitude in supervising elected county officials.
