CACHE COUNTY COUNCIL MEETING March 26, 2002

The Cache County Council convened in a regular session on 26 March 2002 in the Cache County Council Chamber at 120 North 100 West, Logan, Utah.

CALL TO ORDER:

Chairman Anhder called the meeting to order at 5:00 p.m.

INVOCATION:

The invocation was given by Cory Yeates.

REVIEW AND APPROVAL OF AGENDA:

REQUESTED CHANGES TO THE AGENDA:

1. Under item 10b an executive session and resolution 2002-11approving purchase of real property were added to the agenda.

The Council Meeting proceeded with the agenda as amended.

REVIEW AND APPROVAL OF MINUTES:

The minutes of the regular Council meeting held on March 12, 2002 were discussed, corrected and approved.

Council member Gibbons moved to approve the minutes of March 12, 2002 as amended. Hansen seconded the motion. Vote was unanimous, 7-0.

REPORT OF COUNTY EXECUTIVE:

County Executive Lemon reported on the following items:

Appointments: Jack Draxler - Cache County Planning Commission

Wes Roundy - Ag. Preservation Advisory Board

Council member Yeates moved to approve the appointments. Robison seconded the motion. The vote was unanimous, 7-0.

Appointments: Marsha Israelsen, Diana Olsen and Tammy Grange election

judges for the May 7, 2002 College Young Incorporation election.

Council member Yeates moved to approve the appointments. Beck seconded the motion. The vote was uanimous. 7-0.

Warrants: The Warrants for the periods of 3/01/2002 to 3/07/2002 and

3/08/2002 to 3/14/2002 were given to the Clerk for filing.

Other Items:

 Administration Building. Ground Breaking for the new Administration Building on April 2, 2002 has not been finalized yet. Executive Lemon will contact Council members regarding this date.

2. Zoos, Arts and Parks (ZAP) Tax

County Representatives would like to come and talk to the Council about recommending an Advisory Board on the allocation of the tax. They would also like to determine how an organization qualifies to receive a portion of that tax.

Executive Lemon stated: "If Cache County does not put this on the ballot in the General election in November then that opens up the way for all other Municipalities in the county to put it on their ballot the following year." The decision must be made 60 days prior to the General Election.

- 3. IHC Revenue Bonds. In 1990 and 1992 Cache County agreed to execute some Revenue Bonds with IHC, which were issued by Salt Lake County. IHC would now like to refund those bonds and would like to do the same type of thing with Cache County again, having Utah County issue the bonds this time.
- 4. Parking for Merchants during construction of Administration Building. All of the parking North of the Wilkinson building and South of the Courthouse will be taken away during construction. Executive Lemon is recommending that the County allow those employees using County owned vehicles to house their vehicle at their residence during the construction time. Construction time is anticipated to last until June of next year.

BUDGET MATTERS:

There were no Budget transfers.

PUBLIC HEARING SET: TAX RATE HEARING

Council member Yeates moved to set the public hearing for the Tax Rate hearing at 6:00 p.m. on August 13, 2002. Vice Chairman Beck seconded the motion. The vote was unanimous, 7-0

PUBLIC HEARING SET: 2003 BUDGET AND TAX INCREASE

Council member Yeates moved to set the public hearing for the 2003 Budget and Tax Increase at 6:00 p.m. on November 26, 2002. Robison seconded the motion. Vote was unanimous, 7-0.

PUBLIC HEARING SET: OPEN 2002 BUDGET

Council member Gibbons moved to set a public hearing to open the 2002 Budget at 5:45 p.m. on April 9, 2002. Hansen seconded the motion. Vote was unanimous, 7-0.

THE COUNCIL MOVED INTO THE BOARD OF EQUALIZATION.

TAX EXEMPTION REQUESTS:

Tax-exemption requests had been sent to the Council by Auditor Tamra Stones. Action was taken on the first three requests:

- 1. New Discoveries
- 2. USU Research Foundation
- 3. Prince of Peace Lutheran Church
- 4. Bridgerland Community Ice Arena

Council member Robison moved to approve tax exemption requests for New Discoveries, USU Research Foundation and Prince of Peace Lutheran Church. Petersen seconded the motion. All members voting in favor. 7-0.

There were some questions on the Ice Arena that ought to be answered before the final determination of exempt status. In a memo to the Council, Auditor Tamra Stones suggested a hearing be held before granting this request.

County Council March 26, 2002

Vice Chairman Beck moved to have a Sub-committee as Hearing Officers consisting of the Auditor, Assessor, and 3 Council members. Yeates seconded the motion. The vote was 6-1. (Anhder voted no.)

Council member Gibbons moved to amend the motion that there would be a subcommittee made up of three members of the Council, the Auditor, the Assessor, and the County Executive to meet with the BCIA. Vice Chairman Beck accepted the amendment Vote was 5-2. (Anhder and Hansen voted no.)

Members of the Council assigned to serve on the Committee were Layne Beck, Larry Anhder, and Cory Yeates. Executive Lemon accepted the responsibility of setting up the meeting.
