- **EMS Coordinator.** Logan Regional Hospital contacted Executive Lemon and informed him that they would not be able to participate in funding an EMS Coordinator. They found that it was not possible to provide this funding without

- jeopardizing other funding projects. Their legal council advised them not to proceed.
- 3. <u>Email Address for all Council members</u>. An address list was passed to the Council members for their personal email address verfication. The plan was that an email to the County would go to a central location and then could be forwarded to each Council members' personal email.
- 4. <u>Cache Metropolitan Planning Organization (CMPO)</u>. Based on the 2000 Census, the Cache Metropolitan Planning Organization boundaries had been expanded to include all of Nibley, Hyrum and Wellsville.
