COUNTY ATTORNEY'S REPORT ON PENDING MATTERS

Chairman Petersen asked Attorney Daines to report on the progress of the Agricultural Land Use Ordinance. Attorney Daines said the Planning and Zoning Commission will begin having workshops during the last three weeks of January. They will have public hearings in February and should have the ordinance to the Council later in February or March.

COUNCIL MEMBER REPORTS

Cache County Council 12-09-03

Brian Chambers reported he met with the Cache County Mayors Association on December 8, 2003 to discuss the countywide ambulance service proposal. The mayors are very supportive of the concept of countywide ambulance service, but have some questions on the means of funding the service.

Kathy Robison went to the jail meeting, but still had some concerns. She asked Sheriff Nelson if he knew anything about the temporary occupancy permit issue. Sheriff Nelson said he understands the temporary permit will be issued for mid-January and he is still assuming inmate transfers will be in February sometime.
