CALL TO ORDER

Chairman Petersen called the meeting to order at 5:00 p.m. Executive Lemon informed the Council that Lt. Von Williamson of the Sheriff's Department had passed away suddenly. Petersen expressed concern for Williamson's family.

OPENING REMARKS

The invocation was given by Craig Petersen.

PLEDGE OF ALLEGIANCE

Chairman Petersen lead those present in the Pledge of Allegiance.

REVIEW AND APPROVAL OF AGENDA

The agenda was approved with a request from Jeff Gittins for a letter of support for his conservation easement added to item 11d - Request to Sponsor Conservation Easement/Jess Harris - and the addition to item 9a, Board of Equalization, of item No. 2 - Mobile Homes. Petersen said a brief Executive Session will be held following the Council meeting.

REVIEW AND APPROVAL OF MINUTES

Minutes of the April 13, 2004 Council meeting were reviewed and approved as written.

REPORT OF THE COUNTY EXECUTIVE: M. LYNN LEMON

APPOINTMENTS: There were none.

WARRANTS: The warrants for the period of 04-09-2004 to 04-15-2004 and 04-16-2004 to 04-22-2004 were given to the clerk for filing.

OTHER ITEMS

Demolition of Jail Building - Lemon said the American West Heritage Center has asked the county to donate the kitchen equipment from the old jail to the Heritage Center.

ACTION: Motion by Council member Gibbons to donate the kitchen equipment from the old jail to the American West Heritage Center. Cook seconded the motion. The vote was unanimous, 7-0.

Area Plan for Newton and Hyrum Reservoirs - Lemon said there are four options in the proposals. One is no action, one is resource conservation emphasis, one is multipurpose emphasis and one is recreation emphasis. There will be meetings concerning this plan on May 11, 2004, at the Newton Town Hall and May 12, 2004, at the Hyrum City Offices. The entire environmental assessment is available for the Council to review in Lemon's office.

ITEMS OF SPECIAL INTEREST

- Cache County Tourist Council Report Maridene Hancock said the total Transient Room Tax collected for 2003 was \$226,206 and 2002 was \$244,770. Hancock said keeping in mind that 2002 was the Olympics year, Cache County tourism has stayed fairly constant. A visitor survey program will begin the week of April 26, 2004, and Council members were given copies of the survey. The Tourist office is working with David Clyde on his Eagle Scout Project to develop word searches and children's games for a booklet concerning the Logan Canyon Scenic Byway. The tourism conference held April 22-23, 2004, was very successful. The presentation concluded with a video of the Cache Valley advertisements that are airing on KSL-TV, Channel 5.
- Develop Plan for Underground Water Usage Evan Olsen/Ann Peralta each expressed serious concerns about the water situation in Cache County and asked the Council's approval to explore the feasibility and appropriateness of some kind of institutional structure to address water concerns such as: a special services district, a water department or a water authority like the airport authority. Funding of an additional \$10,000 to \$20,000 will be needed for this entity.

BUDGETARY MATTERS

Intra-Departmental Transfer

Department - Jail - Transfer \$9,447.00 from Capitalized Equipment to Non-Capitalized Equipment to cover equipment purchases under \$5,000.

Robison seconded the motion. The vote was unanimous, 7-0.

PENDING ACTION

□ **Update - Historical Courthouse Restoration Project** - Attorney Daines reported on the paint removal being done on the Courthouse. The brick is in better condition than anticipated and the decision to leave the brick as is or to stain it all the same color can be made now or at a later date in the project.

THE COUNCIL MOVED INTO THE BOARD OF TRUSTEES FOR SPECIAL SERVICE AREA NO. 1

Resolution No. 2004-01(Special Service Area No. 1) - Findings and Conclusions on a Landfill Siting Proposed by Solid Waste Advisory Board - Council member Yeates felt the wording of the resolution was inconsistent and felt the Council had not discussed the issue sufficiently. Robison asked to postpone the Council's decision until updated information could be received concerning the most current bid prices for out-of-county disposal. Gibbons said the Council should approve the resolution because it will give the county better bargaining power with those bidding on out-of-county disposal.

Cook seconded the motion. The motion passed, 5 aye - Chambers, Gibbons, Hansen, Petersen & Cook, 2 nay - Yeates & Robison.

The Council adjourned from the Board of Trustees for Special Service Area No. 1.

Willow Park/Fairgrounds Budget - Russ Akina returned to the Council with a handout showing Expenditures and Revenues for years 2002-03 and 2003-04, both actual and projected amounts. Several Council members had questions about the figures.

Chambers seconded the motion. The motion passed, 5 aye - Yeates, Chambers, Hansen, Cook & Robison, 2 - nay, Gibbons & Petersen.

ACTION: Motion by Council member Hansen to waive the rules and approve Resolution No. 2004-13 - Authorizing Executive to Execute Lease Agreement for a Triangular Parcel of Property between Cache County and the City of Hyrum, Utah. Yeates seconded the motion. The vote was unanimous, 7-0.

• <u>Request to Sponsor Conservation Easement/Jess Harris</u> - This is a 10-acre parcel between 4200 and 4600 North on 800 West remaining from an original 25 acres. Fifteen acres have been sold and developed. Harris is asking that the remaining 10 acres be retained as agricultural land. Harris said the county's obligation as a sponsor would be to monitor the property on an annual basis to make sure its use is agricultural.

ACTION: Motion by Council member Cook to approve the request for Cache County to sponsor the Jess Harris Conservation Easement. Hansen seconded the motion. The vote was unanimous, 7-0.

• <u>Request for Letter of Support for Conservation Easement/Jeff Gittins</u> - This is an 88.88-acre parcel north of 4600 North. Gittins is applying to the Department of Agriculture for a conservation easement.

ACTION: Motion by Council member Cook to give a letter of support to Jeff Gittins for a conservation easement. Robison seconded the motion. The motion passed, 6 aye - Yeates, Chambers, Hansen, Petersen, Cook & Robison, 1 abstention - Gibbons.

COUNTY INITIATIVES

- □ **<u>T.V. Translator Survey</u>** Chairman Petersen said the survey is completed and he will present the Council with the results soon.
- RAPZ/Restaurant Tax Allocation Petersen said sixty-nine applications have been received by the committee for a total request of \$3.2 million. There is approximately \$650,000 collected and with commitments already made there will be about \$432,000 of Restaurant Tax money that can be allocated this year.

Based on \$781,000 collected so far this year in RAPZ tax money, the committee made the decision that will allocate taxes up to December 31, 2004 as follows:

RAPZ/Restaurant Tax Coordinator	\$ 9,000
Zoo	\$ 77,000
Cultural arts	\$347,000
Master plan	\$ 25,000
Allocation to cities based on population	\$107,000
Allocation to cities based on projects -recreation	\$215,000

The committee will meet on May 10, 2004. A recommendation to the Council is expected to be ready by June 8, 2004.

Roads - GASB 34 - Establish Maintenance Level - Lemon recommended keeping all asphalt and double chipped county roads at a rating of between 6 and 4, with at least 80% of the roads being kept above a 4 rating.

ACTION: Motion by Council member Hansen to maintain at least 80% of county asphalt and double chipped roads at a 4 rating or above. Gibbons seconded the motion. The vote was unanimous, 7-0.

Public Roads Access - Attorney Daines updated the Council on the procedures and methods of the Roads Committee and their progress thus far.
