The Cache County Council convened in a regular session on December 02, 2008 at 5:00 p.m. in the Cache County Council Chamber at 199 North Main, Logan, Utah.

#### OPENING REMARKS AND PLEDGE OF ALLEGIANCE

Council member Cory Yeates gave the opening remarks and led those present in the Pledge of Allegiance.

#### **REVIEW AND APPROVAL OF AGENDA**

The agenda was approved with the Items 10a(2) (*Property Tax Abatement*) and 11b through 11f (*Final Plat Approvals*) moved to the December 09, 2008 agenda.

#### **REVIEW AND APPROVAL OF MINUTES**

ACTION: Motion by Council member Robison to approve the minutes of the November 25, 2008 Council Meeting as written. Zilles seconded the motion. The vote was unanimous, 7-0.

#### REPORT OF THE COUNTY EXECUTIVE: M. LYNN LEMON

**APPOINTMENTS**: There were no appointments.

**WARRANTS:** There were no warrants.

#### PUBLIC HEARINGS, APPEALS AND BOARD OF EQUALIZATION MATTERS

ACTION: Motion by Council member Yeates to convene as a Board of Equalization. Robison seconded the motion. The vote was unanimous, 7-0.

#### Tax Exemption Request

ACTION: Motion by Council member Yeates to approve the Tax Exemption Request for the Mount Horeb Northwest Latin Conference of the International Pentecostal Holiness Church. Gibbons seconded the motion. The vote was unanimous, 7-0.

ACTION: Motion by Council member Yeates to adjourn from the Board of Equalization. Robison seconded the motion. The vote was unanimous, 7-0.

□ <u>Discussion – CCCOG Road Recommendations-Short and Long Term Financing</u> – Jim Matsumori reviewed different avenues of financing for the road projects including tax anticipation notes and long-term bonds with a mandatory ender of a three or four-year period of time and cautioned the Council to engage the services of bond council even with short-term financing.

Petersen asked what the Council would save in bond initiation fees with short-term financing? Matsumori replied about \$20,000.00; however, a revolving line of credit may incur some similar fee amounts anyway.

Daines said the long-term rate is about 4.6% and asked for an estimate of what the rate would be for five-year short term borrowing? Matsumori said it would probably be between 3% and 4%.

Daines asked if Matsumori would be willing to act as an advisor for Cache County in the financing process? Matsumori said he would be happy to do that.

Executive Lemon reminded the Council that this item is not on for a final decision on the projects tonight. North Logan wants to move forward with its project and asked, as part of its project, for the engineering study fees. Lemon asked if the Council is comfortable with committing \$250,000.00 up front to the North Logan 200 East project for engineering study fees? North Logan has already committed \$40,000.00 towards the engineering fees and North Logan will take the community development tax money and pay it to Cache County.

Zilles said it would be advantageous to the county to have the engineering study completed so the project's costs can be estimated more accurately.

Petersen asked if the Council can approve the recommended CCCOG projects without finalizing the financing method? Lemon responded yes.

Gibbons asked if the Council had agreed on the road alignment on the 200 East project for sure? Lemon replied the Council passed a resolution stating support for the direct

200 East alternate and negotiation is now going on between federal highways and North Logan and the county will have to wait to see how that works out and the first phase of the project does not include the portion of the route that is in question.

Daines reminded the Council that the county needs to set up an abridged agreement regarding North Logan's agreement to pay incremental tax increases back to the road tax fund.

Zilles noted that Nibley's bid numbers may be lower now because the price of blacktop, etc. has come down and, perhaps, should be re-bid. Council members agreed that each of the projects may need to be opened for new bids because of lower oil prices.

Daines suggested that the resolution could include language saying the county will appropriate amounts up to a specified amount but not more than that amount.

Vice Chairman Petersen recommended placing on the December 9, 2008 Cache County Council agenda an item for approval of the Logan/River Heights/Providence 100 East Project and the Nibley 3200 South project and the engineering study fees for the North Logan 200 East project.

ACTION: Motion by Council member Gibbons to approve Ordinance No. 2008-12 – 2009 Salaries for County Council. Chambers seconded the motion.

#### Discussion on the motion:

Gibbons said this will perpetuate the disparity in Council member pay and recommended the Council pay be \$9,531.00 for each member. The amount of \$9,531.00 is arrived at by taking the amount of insurance costs that are over and above the Council salary and dividing it among all Council members. Daines supported the recommendation.

Robison expressed concern at raising council salaries. Gibbons said that much money was in the budget anyway, it has just been redistributed for pay equity. Robison said it still looks bad to the public given other county employees are only receiving a possible 2% increase.

Petersen noted that this would incur taxes; whereas, the insurance had been before taxes. Daines said language such as "equivalent benefits" could eliminate that problem.

ACTION: Motion by Vice Chairman Petersen to amend Ordinance No. 2008-12 – 2009 Salaries for Council to set the salary at \$9,531.00 for Council members and read "Council Member: Regular salary or equivalent benefits for each member" and Gibbons seconded the motion. The vote was unanimous, 7-0.

Chairman Hansen called for the vote on the main motion.

The motion passed, 5 aye – Chambers, Gibbons, Hansen, Yeates & Zilles and 2 nay – Petersen & Robison.

Gibbons indicated he disagreed with Sheriff Nelson's comment at the last Council meeting that the Council should give more input on the budget. Gibbons said the Organic Act states Executive Lemon is the budget officer and complimented Lemon on his work. Vice Chairman Petersen agreed and said this is a bare bones budget and complimented Lemon also.

Hansen said the Sheriff made a legitimate point about the loss of revenue from federal and state inmates and this issue will have to be addressed in the future.

- <u>Disposal of Surplus Property Agree to date for Public Hearing</u> Lemon said this is property that was part of the tax sale in 2005. It is a retention basin in a subdivision and the previous owner did not want it. It was not purchased in the 2005 tax sale, but there is an interested purchaser now. In order to dispose of the property, the county must hold a public hearing and give thirty days' notice. Lemon asked if the Council wanted to start the process to be carried over to the next year's Council or leave it for the next Council to begin the process? The Council opted to place this item on the January 13, 2009 agenda.
- <u>Discussion Position on Ruby Pipeline</u> Executive Lemon said the Council previously passed a motion taking a position opposed to the southern route for the Ruby Pipeline. Lemon recommends now taking no position.

# CACHE COUNTY ORDINANCE NO. 2008 - 12

# AN ORDINANCE PROVIDING FOR SALARIES FOR MEMBERS OF THE CACHE COUNTY COUNCIL FOR 2009.

The County Council of Cache County, Utah, in a regular meeting, lawful notice of which has been given, finds that a public hearing regarding the establishment and change of salaries for members of the Cache County Council was conducted on November 25, 2008, in accordance with Section 17-16-14, Utah Code Annotated, upon lawful notice; that the Organic Act for the Government of Cache County, Utah, as approved on November 6, 1984, authorizes the modification of the salaries of the members of the Cache County Council only by ordinance; and that the County Council deems it appropriate and reasonable to establish salaries for members of the Cache County Council for the period commencing January 1, 2009 and ending December 31, 2009.

Now therefore, the Cache County Council ORDAINS as follows:

# SECTION 1: COUNTY COUNCIL SALARIES

The salaries earned for members of Cache County Council for the period January 1, 2009 through December 31, 2009 shall be as follows:
