# **INITIAL PROPOSAL FOR CONSIDERATION**

Approval/Disapproval – NRCS/Cache High Line Canal Improvements Agreement – Chairman Zilles asked Attorney Swink to update the Council on the proposed agreement. Attorney Swink reported he had reviewed the agreement and clarified some points of concern with Bronson Smart of the NRCS and recommends the Council wait to consider this agreement until after the Joint Council Meeting with Logan City set for March 30, 2010.

Bronson Smart said the NRCS is currently working on the National Environmental Policy Act (NEPA) document which will probably be completed in six to eight weeks when public meetings will be scheduled.

In response to Council member Petersen's question, Smart listed the five alternatives being considered:

- 1. The 3100 North route
- 2. The Highway 89/91 route
- 3. The Lundstrom Park route
- 4. The Canyon Road route
- 5. Do nothing

Smart said the Canyon Road route has the most problems associated with it at this time, but it will still be included in the options for analysis and review.

Council member Robison asked how many people will be affected by the canal project? Keith Meikle, of the Logan, Hyde Park, Smithfield Canal Company, replied there are over 5,000 canal shareholders and Smithfield Irrigation, North Bench Irrigation, Smithfield South, Richmond Irrigation all the way to Cove are all affected. All the land from 400 North in Logan north to Cove is affected as well as the Amalga and Benson areas. Smithfield and Hyde Park culinary waters are tied to the canal.

Attorney Swink commented that Cache County's financial obligation will be transferred to cities and shareholders via sub-agreements before the project begins.

Smart reiterated that even after the agreement is signed by Cache County and Cache County decides not to go forward with any of the project options, there will be no financial liability for the county.

Chairman Zilles indicated this issue will be discussed at the Joint Council meeting of the Cache County Council and the Logan City Council on March 30, 2010. Smart stated he will not be available on that date. Chairman Zilles asked if Bob Fotheringham may represent Smart at the Joint Council meeting? Smart and Fotheringham consented to the request.

Council member Petersen asked if Cache County will incur liability related to the canal project? Attorney Swink said there will be liability associated with the project.

- Resolution No. 2010-14 Authorizing Executive to execute NRCS/High Line
   Canal Improvements Agreement (NO ACTION TAKEN) deferred until after
   the Joint Council meeting on March 30, 2010.
- Letter of Support Green Canyon (Jon White) Conservation Easement Executive Lemon said the Council has authorized similar letters in the past. Council members asked for clarification on the location of the easement and the status of surrounding land as well as the present use of the land. The land is currently used for grazing and is not suitable for other agricultural uses. It is winter habitat for deer and elk and Hyrum City's water system is on the land. This is under the Forest Legacy program.

ACTION: Motion by Council member Petersen to authorize the County Executive to write a letter of support in reference to the Green Canyon (Jon White) Conservation Easement. Chambers seconded the motion. The motion passed, 6 aye – Buttars, Chambers, Petersen, Robison, Zilles & Yeates and 1 abstention – White.

• <u>Discussion – Improving Census Participation</u> — Executive Lemon noted he has had calls from citizens who do not want to complete the requested Federal Census information as a means of protest because they are angry with the federal government right now. He tells them that not completing and returning the Census information will only hurt the county and the state. Class B road money and sales tax distribution and other revenues are determined by the numbers in the Census. Executive Lemon urged the Council to emphasize the importance of returning the requested Census information. Vice Chairman Zilles and Council member Chambers suggested that Executive Lemon advertise the county's recommendation that citizens complete and return the Census information. Executive Lemon said he will look into the possibility of public service announcements on the radio and in the newspaper.





#### NEW ORDINANCE

PURPOSE: To recommend approval of the preliminary & final plat for the Dena Christensen Subdivision and Boundary Line Adjustment to the Cache County Council.

#### PROJECT SUMMARY

The proposal is to create a 3-lot subdivision and Boundary Line Adjustment located approximately 1721 East High Creek Road near Cove in the Agricultural Zone. There is currently one single family dwelling (SFD) on Lot 1, Lot 2 will be used for residential use, and lot 3 is a remainder parcel.

- Access from High Creek Road provides adequate access. The subject road is a 23' wide paved
- Encroachment permits will be required as lots are developed.

# Water & Septic:

- Adequate, approved, domestic water rights will be in place at the time of final plat recordation.
- The proposed lot is feasible for an on-site septic tank system.
- The existing SFD is connected to High Creek Culinary Water Company; the new lot will also be connected to this culinary water system.

#### Service Provision:

- All refuse and recycling containers must be placed along the north side of county road High Creek Road for collection.
- Property owners should allow sufficient space along the shoulder of the road for the placement of the containers to be placed four feet apart, and will not interfere with traffic flow.
- A school bus stop would be located at 1721 East High Creek Road, approximately 2 blocks from the proposed subdivision.

# STAFF DETERMINATION

It is staff's determination that the Dena Christensen Subdivision, a 3-lot subdivision for property located at approximately 1721 East High Creek Road with TIN #'s 09-028-0013 and 09-028-0015 is in conformance with the Cache County Ordinance requirements for preliminary and final plat approval to the County Council. This determination is based on the following findings of fact:


1. The Dena Christensen Subdivision has been revised and amended by the conditions of project approval to address the issues and concerns raised within the public and administrative records.

- 2. The Dena Christensen Subdivision has been revised and amended by the conditions of project approval to conform to the requirements of Titles 16 and 17 of the Cache County Code and the requirements of various departments and agencies.
- 3. The Dena Christensen Subdivision conforms to the preliminary and final plat requirements of §16.03.030 and §16.03.040 of the Cache County Subdivision Ordinance.
- 4. The Dena Christensen Subdivision is compatible with surrounding land uses and will not interfere with the use and enjoyment of adjoining or area properties.
- 5. High Creek Road, the road that provides access to the subject property, has an adequate capacity, or suitable level of service, for the proposed level of development.

# CONDITIONS OF APPROVAL


The following stipulations must be met for the developments to conform to the County Ordinance and the requirements of county service providers.

- 1. Prior to final plat recordation the proponent shall meet all applicable standards of the Cache County Ordinance.
- 2. Prior to final plat recordation an adequate, approved, domestic water right shall be set in place for Lot 2.
- 3. All private drives shall meet applicable requirements of the 2006 International Fire Code and any other applicable codes as adopted by Cache County. Encroachment permits shall be completed as lots are developed.
- 4. All lots shall provide sufficient space for placement of refuse and recycle containers so they do not interfere with traffic.
- 5. The Applicant shall reaffirm the County's 33' from centerline right-of-way for the County road, High Creek Road, across the entire frontage of the proposed subdivision.



General Description – The 5,690 acre project is located in Northern Utah adjacent to the Uintah–Wasatch–Cache NF. Douglas–fir, sub alpine fir and quaking aspen are the primary forest species. The property provides critical wildlife habitat for a vast number of species in Northern Utah. The Green Canyon project is critical winter range for mule deer and elk as well as providing year round habitat for the Columbia sharp–tailed grouse, a state sensitive species. Perched above the towns of Hyrum and Paradise, the project area provides much of the culinary water for both. Green Canyon's 4.5 mile northern boundary runs along the scenic Blacksmith Fork river, a "Blue Ribbon" trout stream. Brown and rainbow trout are the primary species. The river also provides habitat for the Bonneville cutthroat trout, a state sensitive species. Green Canyon has been owned by the landowner and his family since 1906. They use the land for timber harvest, seasonal grazing of 40–50 cow/calf pairs as well as recreation. The landowner has a deep conservation ethic and has put all of his cropland (see map) into the Farmland Ranch Protection Program and strongly desires to keep the forested property in its pristine condition and protected from development as well.


# **PROJECT FEATURES**

# **Important:**

- A. Forestry: In 1996, Barney White recieved Utah's Association of Conservation Districts and the State's Forester's Landowner of the Year award. John White holds the same values for the land as his father did.
- B. Forestry: Timber harvests have taken place over the years. Five years ago, 418 acres were helicopter logged. A timber harvest is in the planning stages at this time. The land

owner is following his Forest Stewardship Plan.

- C. Forestry: Other practices completed and in progress as outlined in the FSP; thinning, fuels reduction, aspen regeneration, tree planting and spring development for both wildlife use and livestock.
- D. Forestry: The landowner has an active noxious weed program. Weeds are sprayed annually especially on distrurbed areas, hand sprayed along the Blacksmith Fork with emphasis on areas were the landowner allows public camping and other recreation use.
- E. Economic: The property provides forest products for lumber, firewood, Christmas trees and other forest products.
- F. Economic: Forty to fifty cow/calf pairs are grazed on the land between late May and early October. The calves are sold at market in November. .
- G. Wildlife: The property is key critical winter range for mule deer, elk and moose in Northern Utah. Winter range in the area is disappearing at an alarming rate due to encroaching development.
- H. Wildlife: Utah's WL Action Plan describes winter range as a precious commodity that needs to be preserved. "The Division would have to rethink how we manage deer and elk in Cache Valley if this property were to be lost to development." Utah Div. of WL.
- I. Wildlife: Several hundred elk leaving Hardware Ranch Wildlife Management Area during the fall migrate to the winter range provided by the Green Canyon Property.
- J. Wildlife: The landowner is working with the Division of Wildlife Resources on a major project to re-vegetate the northwest corner of the property for mule deer winter habitat.
- K. Wildlife: The project provides habitat for a variety of other species including black bear, bighorn sheep, turkey and snowshoe hare (key pray for Canade lynx which frequent the property). Antelope have also been seen on the property.
- L. Wildlife: Wolves have been known to use the property, however, no known packs are established in Northern Utah at this time.
- M. Sensitive Species: Green Canyon provides crucial year-round habitat for the Colombian sharp-tailed grouse.
   This species has been petitioned for listing under the Endangered Species Act.
- N. Sensitive Species: The Bonneville cutthroat trout, native to the Great Basin, are rare but several populations exist in the 4.5 mile section of the Blacksmith Fork that borders the project area. Other fishing opportunities include brown and



rainbow.

- O. Wildlife: Over the years, the Blacksmith Fork has been one of the more productive trout streams in the region. The river is considered a "Blue Ribbon" trout stream to anglers and is the only significant river left in the area with a Salmon fly hatch.
- P. Wildlife: The property provides nesting and foraging areas for osprey as well as numerous pairs of bald eagles and golden eagles.
- Q. Water Supply: Two cities rely on the property for their culinary water. Hyrum City has two springs on the property and the Paradise City watershed is on the south boundary. The water quality exceeds the State of Utah standards and "is cold and good."
- R. Watershed: The owners have installed culverts and developed springs, according to NRCS specifications, to reduce erosion into the adjacent river.
- S. Public Access: The public has access to 4.5 miles of fishing, kayaking, hiking, biking along the Blacksmith Fork River and northern property boundary. Public camping is allowed along the river.
- T. Public Access: Hyrum City and the landowner are completing a highly anticipated extension to the Bonneville Shoreline Trail (BST) and a trail head along the north end of the property. The 280 mile trail runs from the Idaho border to central Utah.
- U. Public Access: Green Canyon is part of a Cooperative Wildlife Management Unit (CWMU). The CWMU allows the public to apply for hunting permits on the property through the Utah Division of Wildlife Resources.
- V. Public Access: The Top of Utah Marathon, with more than 2,500 participants, starts at the Top of Blacksmith Fork Canyon and crosses portions of the property.
- W. Scenic: The northern 4.5 mi. of the property borders the Blacksmith Fork River and the Unitah-Cache-Wasatch National Forest. The western end the property provides picturesque views of the mountains for the more than 50,000 residents of Cache Valley.
- X. Scenic: Many people use Highway 101 that borders and crosses the property to access the national forest land for camping, hiking, fishing, hunting, snowmobiling and just enjoying the scenic views which are particularly beautiful in the fall.
- Y. Historic: The property has been owned and managed by the family since 1906. The first woodland harvesting plan in Northern Utah was developed by the Utah Division of

Forestry, Fire &State Lands with Barney White, the landowner's father.

# Threatened:

- A. An offer has been presented for property bordering the Blacksmith Fork river. County zoning allows 40 lots in this area. The landowner is holding the offer until they see if a conservation easement can be obtained on the land.
- B. With the economic conditions of logging and ranching in Utah, the landowner is considering selling the lower elevation property for sub-divisions but is hoping he will be able to obtain a conservation easement to prevent this action.
- C. It is the landowner's desire to do away with the need or the threat of future generations needing or desiring to sell the property for development. The landowner follows in his father's footsteps as a steward of his land.
- D. The landowner put all of his cropland into the Farmland Ranch Protection Program six years ago. He would like to put his forested land under an conservation easement as well that can be passed on to future generations of land stewards.

# Strategic:

- A. The property is bordered on north by the Uinta-Wasatch-Cache National Forest. It borders the Millville Wildlife Management Area to the North as well. It is 2.5 miles West of the Hardware Ranch Wildlife Management Area.
- B. This is a focus area for conservation easements in the state. The State of Utah's LeRay McAllister Critical Land Conservation Fund has invested in five different conservation easements within five miles of the property.
- C. The US Department of Agriculture has four Farm and Ranch Land Protection easements within three miles of this area.
- D. A number of land trusts have been actively engaging with the State and local governments and federal agencies to work with private land owners to obtain conservation easements in the southern end of Cache Valley.
- E. A conservation management plan was developed in conjunction with the Blacksmith Fork Conversation District in 1962 to assist in understanding what management goals and tools were consistent with the wise use of the land.
- F. Cache County is the only county in Utah that has developed and uses the LESA (Land Evaluation and Site Assessment System). This type of easement ranks high for the program.
- G. Along with the Forest Stewardship Plan on this forested property, the cultivated property to the west (see map) is under a Conservation Plan developed by NRCS and the Blacksmith Fork Conservation District.

#### Ready:

- A. The Forest Stewardship Plan has been in place since 1994. The landowner has been active in managing the property in accordance with the plan.
- B. A draft conservation easement is in place.
- C. The landowner has committed to donating a 25% cost share match.

• Supporting parties include: Bear River Resource Conservation and Development Council, Blacksmith Fork Conservation District, Cache County, City of Paradise, Hyrum City, The Trust for Public Land, Uinta-Wasatch-Cache National Forest and Utah Division of Wildlife Resources


