Each application was reviewed and discussed by the committee members, then a recommendation of an award amount was presented. If there was no opposition to the recommended amount, committee members agreed to recommending the amount to the County Council. Applications from the same entity were discussed at the same time. If the committee members had questions and someone representing the entity was present, they were invited to the podium to answer the questions. A few of the applications were given a star during the meeting, and if any funds were left, the committee would return to discuss the applications with stars.

The code was reviewed about the amount of money allocated to Zootah, whether it is 10% or up to 10%. The discussion led to state that the application was not acceptable. It was pointed out that if one applicant was invited to submit another application, it opens the opportunity for other applicants to submit a revised application too. The code states that applications must be submitted by a deadline, the first Friday in March. The committee recommended that Zootah receive a \$160,000 award.

The committee took a lunch break at noon.

The meeting reconvened at 12:19 p.m. after a lunch break.

After all applications were discussed, and recommended award amounts were reviewed, and the remaining amount was calculated to ensure there was still money available, the committee members discussed the applications with a star. Some of them received additional funding.
