1. Call to Order

Executive Zook called the meeting to order at 10:05 a.m..

2. Items of Business

The 2025 meeting minutes will be reviewed and approved by the board via email.

Alma Burgess presented an overview of the RAPZ and Restaurant Tax Program and process.

The board discussed applications alphabetically by entity name; see the list of recommendations for the order in which they were discussed.

3. Items of Discussion

During the weeks leading up to the meeting, board members reviewed and scored each application. The scores were submitted before the meeting and tallied, giving each application a cumulative score..

During the meeting, the total cumulative score for each application was revealed, a process that served as the foundation for funding decisions. The board members reviewed and discussed each application, leading to a recommendation of an award amount. If there was no opposition to the recommended amount, board members agreed to recommend the suggested amount to the County Council.

Applications from the same entity were discussed at the same time. A few applications were marked during the meeting, and if any funds were left, the board would return to discuss the marked applications. A break was taken at 11:55 a.m., and then Executive Zook called the meeting to order at 12:37 p.m. to resume and discuss the remaining applications. After all recommendations were made, the total recommendations exceeded the available amount. The board had to cut some of the suggested award amounts to have a balance of funds, \$54,708 still available.
